Venue Rental Rates:

- Weekday (Monday-Thursday): \$1,500.00
- Friday & Saturday: \$4,000.00
- Sunday: \$3,000.00
- MYC Member: 50% Member Discount

Included with venue rental:

- Use of the MYC campus for a 7-hour rental period between the hours of 9:00 am – 11:00 pm
- Use of outdoor waterfront gazebo
- Use of dock and piers for photos

Rental Deposit:

The non-refundable rental deposit must be paid at the time your reservation is made. The rental deposit will be applied toward the overall rental fee. The remaining balance will be due 60 days prior to the date of your reservation.

- Weekday Deposit - \$750.00
- Friday & Saturday Deposit - \$2,000.00
- Sunday Deposit - \$1,500.00

Event Insurance:

30 days prior to the date of your reservation, signer must provide the Maryland Yacht Club with documented proof (Certificate of Insurance or C.O.I) of a Special Event Liability Insurance Policy for a minimum of \$1,000,000 per occurrence with host liquor liability. The Maryland Yacht Club will be named as additional insured.

What it Protects:

The Special Event Liability Insurance Policy protects you against financial responsibility in the event of:

- Bodily injury and property damage liability – up to \$1,000,000 per occurrence and \$2,000,000 total.
- Host liquor liability insurance

How to Obtain:

- The company, organization, or homeowner's private insurance can provide the coverage.
- Website such as PrivateEventInsurance.com or MarkellInsurancesFun.com will provide insurance for the day of your event.



~Bar Arrangements~

All bar services must be provided by the Maryland Yacht Club.

Four Hour Bar Package:

Non-Alcoholic Bar - \$10.00 per person, *inclusive of service charge and sales tax*

Well brands: \$29.00 per person, *inclusive of service charge and sales tax*

Premium brands: \$32.00 per person, *inclusive of service and sales tax*

Top Shelf brands: \$35.00 per person, *inclusive of service and sales tax*

Four Hours Beer and Wine:

- Unlimited domestic and imported beer, assorted wines and soft drinks
- \$27.00 per person, *inclusive of service charge and sales tax*
- Cash bar for mixed drinks

Wines with Dinner and Champagne Toasts:

Our wine and champagne list changes frequently. Our Event Coordinator will be able to provide you with detailed availabilities three months in advance of your event date.

~Beverage Service Items~

All bars include the following:

Assorted soft drinks, water, mixers, and garnishes:

Coca Cola, Diet Coke, Ginger Ale, Tonic Water, Club Soda, Orange Juice, Pineapple Juice, Grapefruit Juice, Cranberry Juice, Grenadine, Tomato Juice, Bloody Mary Mix, Sour Mix, Lemons, Limes, Cherries, and Olives. *Crystal cut disposable cups, napkins, stirrers, ice, setup, and breakdown are included. This service can be provided from one to four hours.*

Basic, Premium & Top Shelf Bars:

This service includes designated beer, wine, and liquor assortments. This is billed directly to the host on a per person basis.

Beer and Wine Open Bar:

This service includes five types of imported and domestic beer, and five types of wine. This is billed directly to the host on a per person basis.

Non-Alcoholic Bar:

This service includes assorted soft drinks, water, juices, and garnishes. This is billed directly to the host on a per person basis.

Cash Bar:

This service allows your guests to choose their choice of beer, wine, and liquor from our fully stocked bar. This is billed directly to your guests

All events held at the Maryland Yacht Club must be catered by one of our Authorized Caterers. Caterers are responsible for all setup and cleanup of the facility. Self-catering and potluck are not permitted at the MYC. A caterer must be chosen no later than 60 days prior to the date of your reservation. Cakes and desserts can be provided by outside vendors. However, the Authorized Caterer chosen must agree to serve the cake/desserts.
