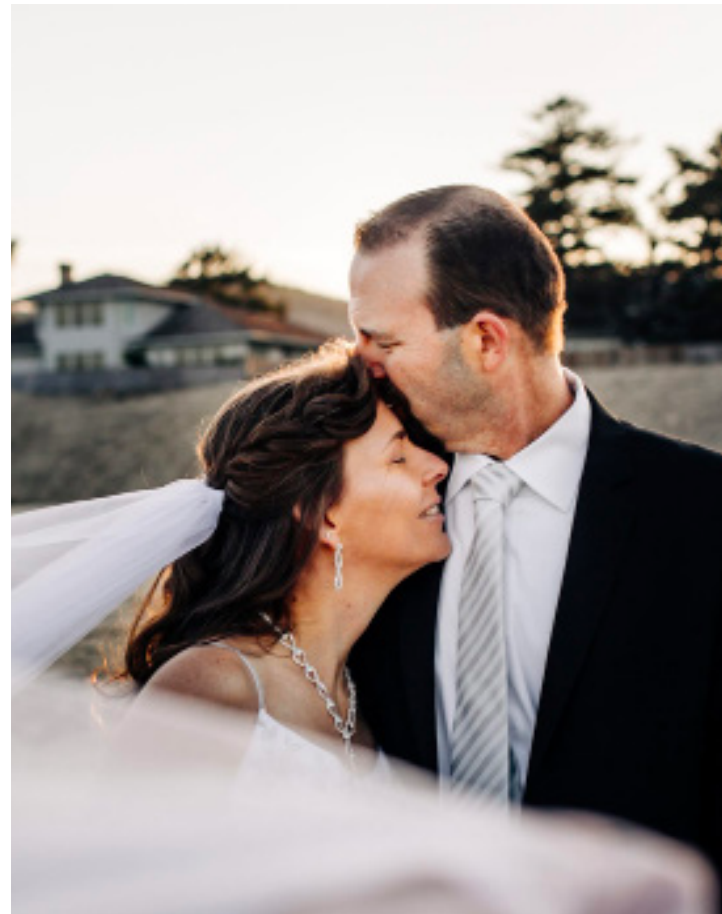

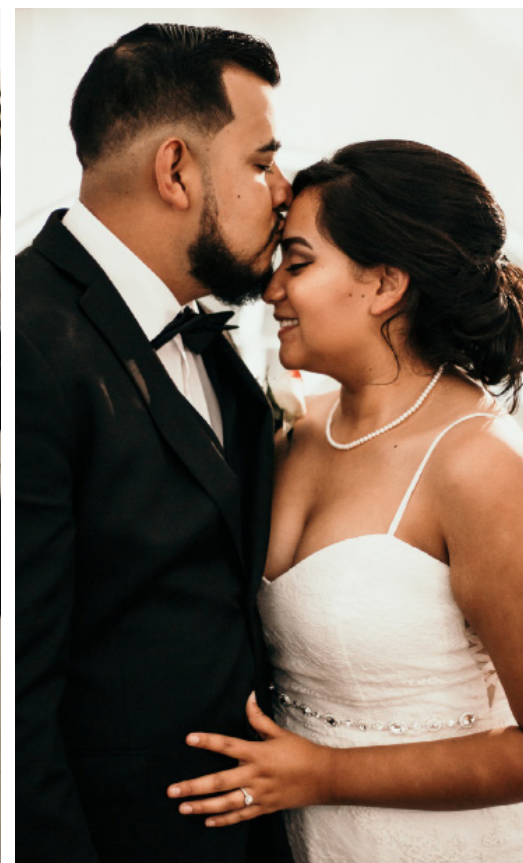
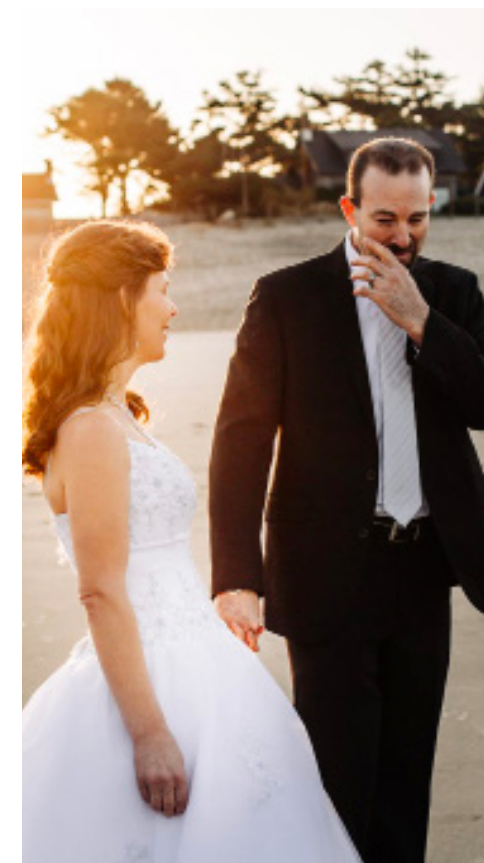

*A time for the two of you to celebrate your upcoming wedding. Intimate, real, with a laid back setting.*

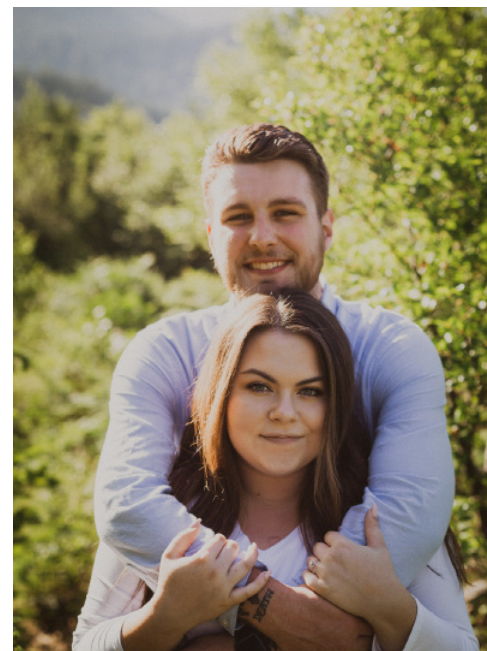
I absolutely love engagement sessions. This is a great way for us to get to know each other before the shoot. Most of my clients feel at ease after an engagement session, and this helps them to feel more comfortable on their wedding day. I love to be involved with planning these. I send an email with a session guide that has tips on what to wear, location options, and prop ideas, to get us started. I am happy to help out with outfits, so feel free to email or text options!

## FAQ

## HOW MANY WEDDINGS DO YOU BOOK A YEAR?

To ensure all of my clients receive the proper attention to detail from start to finish of the creative process I only take 10-15 weddings per year.

## HOW DO YOU DELIVER PHOTOS?

Via Pixieset - an online gallery service that allow you to view and download your gallery on your mobile device or desktop. You can also share and download your gallery an unlimited number of times.

## DOES IT COST TO HAVE YOU TRAVEL?

If your wedding or shoot is further than 1 hour away from Hillsboro, OR I do charge a travel fee. Travel fees are quoted depending on location, so let me know where your wedding or shoot will be, and I'll get you a quote.

## HOW MANY IMAGES CAN WE EXPECT?

On average I deliver 100 photos per hour of coverage. This can vary, though, depending on what all is going on during your wedding. Some weddings include many different events and happenings or a lot of people so they'll receive more photos, and others are very intimate will less people or less going on so it'll be less photos delivered.

## DO WE GET PRINTING RIGHTS?

Absolutely! You have full printing rights to all of the images. Reach out if you would like your images printed through me!

## HOW MUCH IS THE DEPOSIT AND IS IT REFUNDABLE?

I require 50% of your package total to be paid upon booking. This deposit is non-refundable, because I have reserved the date for your event and am turning away other business on that date.

**WHAT IS YOUR TURN AROUND TIME?**

I pride myself on always offering a quick turn around time. I deliver a sneak-peak gallery of approx. 20 images within 24 hours after your wedding (talk about instant gratification!) and then deliver the full gallery within 1 week.

**WHAT DO WE DO IF IT'S RAINING AT OUR ENGAGEMENT SESSION OR WEDDING DAY?**

For engagement sessions, we have a few options. If it's not torrential downpour, we can absolutely power through the shoot. However, if it's raining too hard, my equipment could get damaged, so it's best to reschedule. If you are super particular about your hair and makeup, I definitely recommend rescheduling. I typically like to watch the weather as the date approaches, and discuss options with you leading up to the scheduled date.

For weddings, I always bring something to protect my camera just in case. If you're up for it, I love getting umbrella shots in the rain. I am also very accustomed to shooting indoors, so I have no problem moving things inside.

**DO WE NEED A SECOND SHOOTER?**

I shoot 80% of my weddings on my own. Many times I'll have a second with me when you want BOTH guys' and girls' getting-ready photos, and they are separate locations, when your coverage time is limited, or you're just having a big wedding. If you can fit it in your budget I always recommend it so you get different view points and no moment goes uncaptured. My husband often second shoots for me; when he can't I hire a second that shoots with a similar style.

**DO YOU SHOOT MORE COLOR OR BLACK AND WHITE?**

I shoot mostly color, but I also edit a ton of images in BOTH color and black and white. I rarely ever give an image in only black and white, so you'll have both options.

**HOW DO YOU ACCEPT PAYMENT?**

I send invoices through Square payments. You receive your invoice through email and the included link will direct you to the Square website where you will be able to enter your credit card info and pay from there. It is 100% secure and will charge you no extra service fees.

**DO YOU SHOOT WITH LIGHTING EQUIPMENT?**

Whenever possible I try to shoot with natural lighting. Especially for outdoors, the difference between shooting with natural sunlight and a flash can drastically change the mood. Lighting equipment often can lead to guests tripping over light stands or being bothered by the bright flashes. I do bring on camera flash, though, for low light reception coverage when needed.

**WILL YOU DIRECT US?**

Definitely! Although I have a candid style of shooting, I actually do a lot of directing at my shoots. I'll tell you where to stand, what to do, and give you actions to perform. I leave room for interaction and am always watching for the moments you forget yourself and relax. If you're a bit uncomfortable in front of the camera, no worries! I'll watch for moments where you're not sure what to do and give you plenty of direction. Most of my clients are not professional models, so they feel awkward at first, but trust me, once we start shooting you'll relax and have fun.

**DO YOU MAKE YOUR OWN TRAVEL ARRANGEMENTS?**

To make things easier on us both I do book my own travel - including flights, rental car, and hotel stays. When shooting out of state weddings I always make sure I'm there the day before your actual wedding date just in case of a delayed flight and to make sure I'm well adjusted to the area and any time changes before your big day.

If you decide to book at any point, I'll send over a digital contract. The non-refundable deposit is 50% of your wedding package and is payable via Square payments (invoice to be sent upon booking). The remaining balance is due 30 days prior to your wedding date.

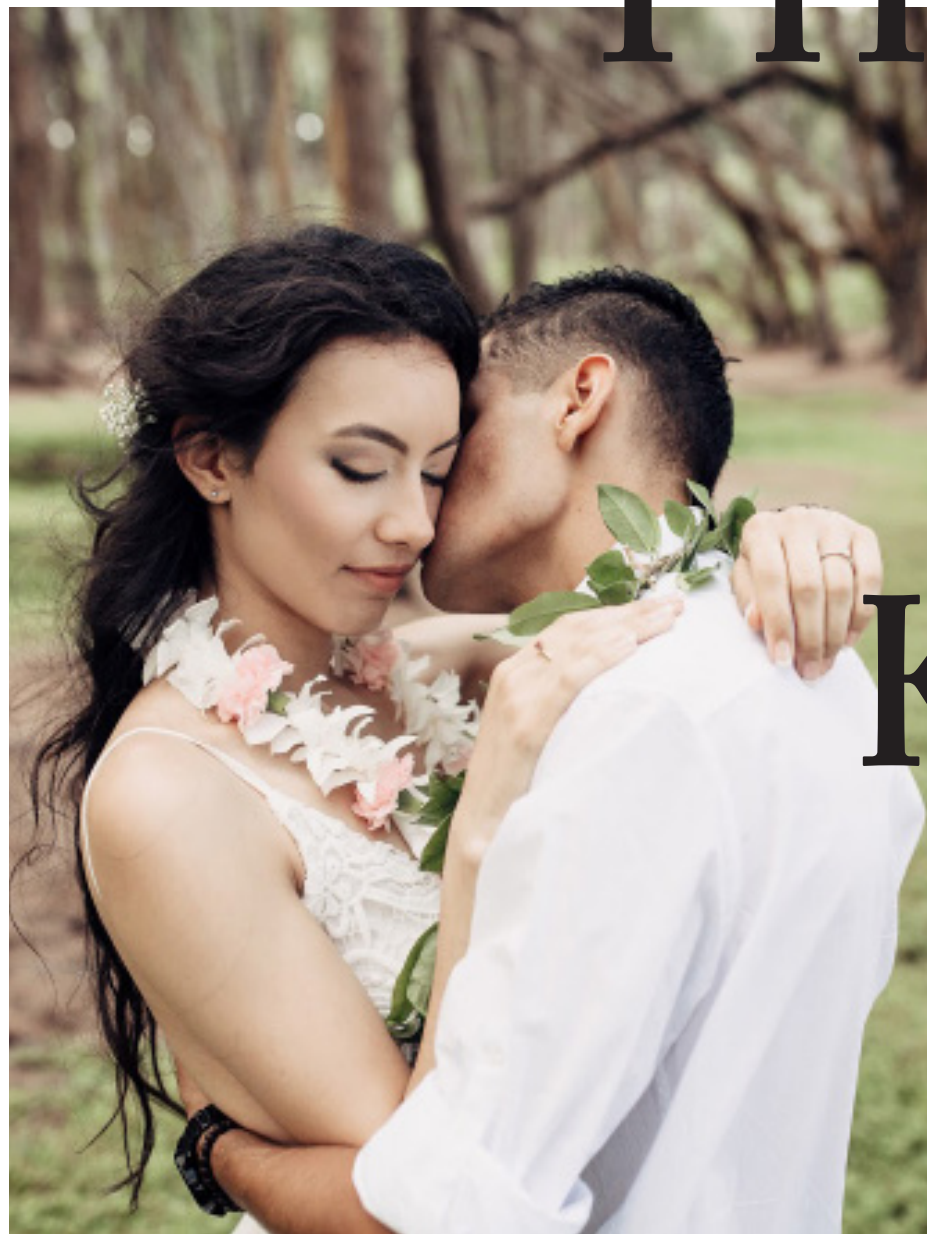
