*From experience, last minute services are sometimes requested on the day of the wedding, if the Artist's schedule allows, additional services can be added.

Trial application is recommended & available for the same rate above. TIP: Book your Trial the same day as your shower, photo session, party.

services for a total amount of \$ to be paid in the form of cash to the Artist, Katy Bryant. A **non-refundable deposit of \$** is due upon signing of the contract to reserve the EVENT date. Mail payment & contract promptly to: **2317 SW 15TH ST BENTONVILLE, AR 72712**. Deposit can be sent instantly at any Walmart Money Center, paid with a local check (Northwest Arkansas branch) or Money Order. The deposit will be deducted from the total balance of \$ leaving a remaining balance of \$ to be paid in the form of Cash on or before EVENT. A tip to the Makeup Artist is a great way to say "Thank you!"

RESERVATION: A signed contract and deposit are required to reserve the dates and times of the EVENT. If the EVENT is rescheduled, postponed, or cancelled; or if there is a breach of contract by the CLIENT, the deposit is non-refundable. If the EVENT is cancelled 30 days or less before the date of the EVENT, the entire remaining balance is owed at time of cancellation.

ENTIRE AGREEMENT: This agreement contains the entire understanding between the ARTIST & the CLIENT. It supersedes all prior and simultaneous agreements between the parties. The only way to add or change this agreement is to do so in writing, signed by all parties. In the event that any part of this agreement is found to be invalid, the remainder of this agreement shall remain valid and enforceable. Any agreement to waive one or more provisions of this agreement or any failure by one or both parties to enforce provision of this agreement shall not constitute a waiver of any other portion or provision of this agreement.

EVENT SCHEDULE: Retaining the ARTIST does not reserve the ARTIST for the entire day of EVENT. The ARTIST reserves the right to book other appointments on the day of EVENT. The EVENT timeline must be agreed to upon initial booking. A service may be added in a timely manner with the approval of the ARTIST. The CLIENT must notify and get approval from the ARTIST regarding any changes in schedule or location.

SERVICE LOCATION REQUIREMENTS: Location of service for the EVENT will be at the discretion of the CLIENT. A set-up table/work area needs to be available for the ARTIST at said location. Ample lighting, whether natural or artificial, is necessary for services to be performed properly.

TRAVEL: Travel is available for services with a minimum total of \$150. The ARTIST travels to The Ravington in Centerton, AR free of charge.

COMPLIMENTARY: The ARTIST will provide a complimentary coffee or mimosa for parties with a minimum service total of \$225. The ARTIST will check photo ID to verify CLIENTS are 21 years old before serving champagne. The ARTIST will provide 1 beverage per paid CLIENT.

USE OF IMAGE: The CLIENT hereby assigns the ARTIST the right to use and publish photographs of the CLIENT and EVENT of which the CLIENT may be included for social media portfolio, advertising and any other purpose and in any manner and medium.

LIABILITY: All brushes and products are kept sanitary. Airbrush foundation is hypoallergenic. All skin conditions and allergies of the CLIENT or bridal party should be reported to the ARTIST prior to application. The ARTIST can not be held accountable for any allergic reactions or complications. If needed, a sample test area on the skin may be requested.

EXTENUATING CIRCUMSTANCES: In the event the ARTIST is unable to provide services the ARTIST will provide a replacement ARTIST of her choosing. *This has never happened before.
