



## WEDDING PHOTOGRAPHY CONTRACT

1. This agreement constitutes an order for wedding portraiture services, including the taking of wedding pictures as agreed to by both parties: The Photographer, Erika Sidor, and Contracting Party (Client). Unless otherwise specified, it is understood that any and all rights to proofs, final or sample prints, thereof shall remain the property of the Photographer and may be used for advertising, display or any other purpose thought proper by the Studio.

2. If Photographer cannot perform this Agreement in whole or in part due to situations beyond the control of the parties or due to Photographer's illness or injury, then Studio will return all fees to the Client(s) but shall have no further liability with respect to this Agreement. Every effort will be made to arrange a backup Photographer in the event of an emergency. This limitation on liability shall also apply in the event that photographic materials are damaged in processing, lost through camera malfunction, lost in the mail, or otherwise lost or damaged without fault on the part of Photographer. Client(s) agree that an entire wedding cannot be replicated, reenacted or repeated for the purpose of a re-shoot and limits the Photographer's liability to the amount paid under this contract.

3. On signing of this agreement, the Photographer will reserve the time agreed upon and will not make another reservation for the specific time frame. For this reason, all deposits are non-refundable even if the date is changed or if the wedding becomes cancelled for any reason.

4. A deposit of \$500 is due at the signing of this agreement, with a further payment of all necessary expenses to be paid upon delivery by Photographer of USB drive with digital images. The deposit is non refundable in case of cancellation or date change by client.

Fees for photography are as follows:

4 hours \$1,600. 5 hours \$1,800. 6 hours \$2,000. 7 hours \$2,200. 8 hours \$2,400. 9 hours \$2,600. These charges include 1 professional photographer (Erika). Adjustments may be made if you want a second photographer for the whole day (flat fee, add \$500).

If client would like to have a Proof Book supplied along with USB of images, this is an additional \$200.

Additional fees for travel will be discussed and arranged depending on the Client(s) location for wedding and reception.
