## Pricing Sheet for Pre-Marital & Officiant Services

### Pre-Marital Counseling

TalkDr Christian Counseling offers pre-marital counseling for engaged couples. You will have 6-to-8 sessions to help you prepare for marriage by looking at all aspects of your relationship and how you can ensure your relationship thrives after marriage.

#### **How Prepare-Enrich marriage counseling works**

The program starts with a relationship assessment that you and your partner take online. Then, you will meet with one of our therapists to review your results and participate in discussions and exercises to build relationship skills in preparation for marriage or to enhance your existing marriage.

During the sessions, we'll identify your relationship strengths and growth areas as a couple, improve your communication skills, reduce your personal and couple stress, learn conflict management skills, compare your family backgrounds, and explore your personality traits.

#### **Pricing**

To schedule a counseling session, the base (minimum) fee is \$75/hour with most sessions lasting an hour and a half. Each, per-hour fee is based on \$1 per \$1K of your combined household's annual gross income. For example, if you and your partner's annual income is \$100k/year, the corresponding fee would be \$100 per hour. No fee is more than \$250/hour.

#### **Pricing**
