As a wedding officiant I know that couples are looking for someone who will help to make their wedding memorable. I will create a beautiful ceremony that will reflect the love in your hearts.

Serving Central Florida and the surrounding areas. I am certified as Florida Public Notary who is authorized to perform marriages throughout the State of Florida as well as a life coach and spiritual director.

**What's included in Officiating Services:**

- An initial one (1) hour complimentary consultation (in-person or remote) is included with all ceremony planning
- Unlimited remote consultation (phone, text and email) prior to the ceremony
- Travel time to your ceremony and up to 2 hours on-site
- Ceremony design, writing of vows or assistance with writing your own vows
- Completion and filing of your marriage license to appropriate County Clerk of the Court – you will generally receive your finalized marriage license from the State within 10 business days
- Religious or secular ceremonies performed according to your personal requests and specifications
- Optional attendance at rehearsal for an additional fee

**CONSULTATION:** Prior to your wedding day, we will work together to create the perfect personalized, custom script for your ceremony. Consultations are included and can be done in-person, via phone or email.

**UNLIMITED SCRIPT EDITS AND ADDITIONS:** You choose the script length and you have final approval of the ceremony script. Once we go over details, I draft the script for you to review and input. You are welcome to have friends or family come forward to do a reading.

**WEDDING DAY:** Arrival at least 45 minutes prior to the ceremony venue to meet with your wedding coordinator and/or other wedding vendors and answer any questions as well as set up any items needed for the ceremony and secure your marriage license. Depart about 30 minutes after the ceremony or as long as needed to secure witnesses for your marriage license.

**FILING OF MARRIAGE LICENSE:** You will be responsible for purchasing the marriage license from any County Clerk's office in Florida that issues marriage licenses and bringing it to the venue. We file your marriage license at the courthouse either in person or by registered mail. Please note:

- A Florida marriage license is required for all marriages performed in the State of Florida
- You do not have to be married in the same county where you obtain your license
- The marriage license must be **on the premises** when the ceremony is performed
- The license expires exactly 60 days from the date of issue
- There is a 3-day waiting period for Florida residents. This waiting period is waived for non-residents.

**PAYMENT TERMS:**

- **A non-refundable deposit of 50% of the service fee is required at time of reservation**
- Final payment must be paid no later than **one (1) week before service**
- Payments may be made by cash, credit card or via PayPal or Zelle

In order to book and secure your date, you will need to sign a Wedding Officiant Agreement which will be provided upon request.
