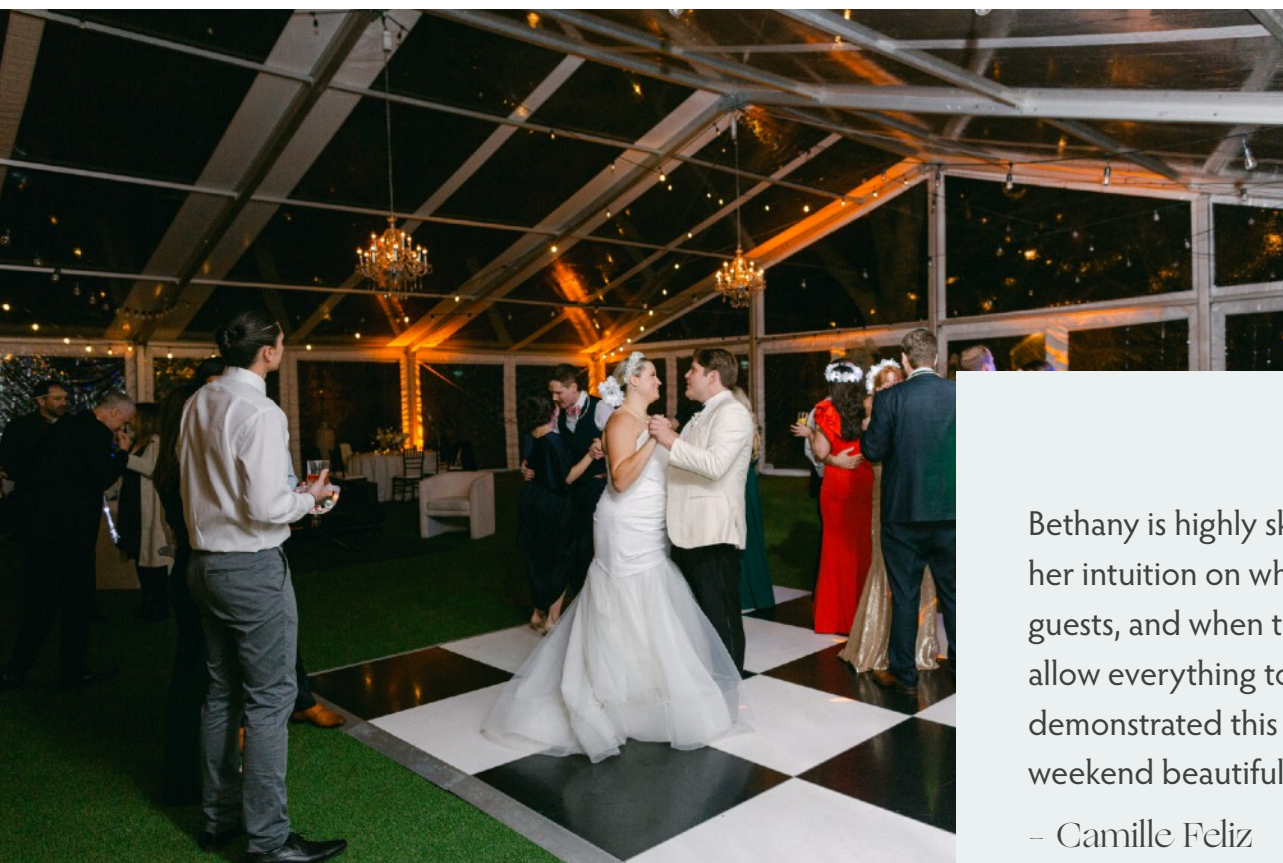

To help you fully understand the packages listed above, I wanted to clarify some very important points:

My second shooter and I will be at your service throughout your entire wedding day. We will be able to capture different angles, and ensure the most important moments are not missed.

You can count on at least 85 images per hour to be captured during each part of the event that I am covering. Odds are that you'll receive more than this (because epic celebrations always merit lots of photographs), but this is a good average to depend upon.

There will be a mixture of candid and posed photographs captured. At certain points during the day, I may pose you, your wedding details, your bridal party, and anything you advise me upon. The candid photos will be taken throughout the wedding day, especially during the reception and dance parts of the party.

# What's Next

## **Consultation: 8-15 months before your wedding**

Let's collaborate to define your wedding day's atmosphere, vision, and schedule. Once we clearly understand your photography needs, selecting the most suitable package will be effortless. If you have difficulty determining which additional options to include, don't worry, you'll have the flexibility to add extra coverage up until the day of your wedding and the option to add prints and albums up to a year after the event.

## **You've booked your wedding photographer!**

After we have finalized all the details, I will present you with a contract and an invoice for a non-refundable deposit of \$1,500. The final payment is due on the day of your wedding, though you are welcome to make the payment at your convenience. Once the contract is signed, and the deposit invoice is paid, you've officially booked your photographer!

## **Guidance and Preparation: After the contract and invoice are complete**

You will receive a 25+ page client guide that will help make your wedding planning a breeze. I'm also here to support you throughout the entire process.

## **Session Scheduling: 9-12 months before your wedding**

If you have scheduled a bridal or engagement session with me, this is the time to schedule them! These sessions are an excellent opportunity for us to get to know each other better and for you to feel more at ease in front of the camera. After all, we will be spending a considerable amount of time together at your wedding.

## **Tips & Tricks: 6 months before your wedding**

I will send you a list of helpful tips to ensure you are fully prepared for your wedding day photographs. From my experience, when clients are well-prepared for every aspect of their special day, they can fully relax and savor the moment, resulting in photographs that truly capture the depth of their emotions.

## **Finalize Timeline: 2 months before your wedding**

I confirm all the details of your timeline and handle any adjustments that need to be made.

## **Final Invoice Sent: 1 month before your wedding**

However, it's not due until the day of your wedding.

## **Final Check-in: 1 week before your wedding**

If you have a planner or coordinator, I will check in with them to ensure we are aligned on any final changes. I will also keep a close eye on the weather forecast and make any necessary adjustments to the timeline to ensure that your special day goes as smoothly as possible. Please do not hesitate to reach out to me via text or phone with any questions or concerns.

## **Your Wedding Day!**

My team and I arrive 15-30 minutes early to get set up. With a detailed shot list and an airtight timeline, you can have confidence that we will capture all the moments, big and small!
