### **Trial Consultation**

- Included: Professional airbrush and traditional makeup trial consultation.
- Having a trial consultation is recommended as an important addition to event day services to avoid any unexpected complications.
- This service option will not guarantee availability of an event date, as event date is not reserved till remaining amount of the event day service is paid in full.
- Trial and day of event bundle options listed below.
- Trial consultations to be held at professional's home studio. Please feel free to bring a friend along to your trial consultation for support and critique.
- This service may be purchased at time of trial or prepaid.
- Trial service fee is refundable due to cancellation prior to service rendered.
- Final payment of additional service fees due the day of trial. View additional service fees below.
- With a trial, one set of strip eyelashes will be included with the purchase of any event day reservation.
- Please plan on 1-2 hours for your trial consultation trial appointment.

For your trial, I will do my best to work with your schedule. I have most weekday evenings available; Mondays, Tuesday, Thursdays, and Fridays beginning at 5:30pm or after; Wednesdays beginning at 5pm or after; Saturdays and Sundays AM and PM. As a majority of my Saturdays are devoted to bridal wedding applications, I typically do not schedule trials on Saturdays April - October.

- Included: Professional airbrush makeup trial consultation and application, day-of application, one set of strip eyelashes, and travel\* . \*30 miles roundtrip included without additional service fees.
- Final payment of additional service fees due at time of trial. Please review additional service fees below.
- Trial consultations to be held at professional's home studio. Please feel free to bring a friend along to your trial consultation for support and critique.

Thirty miles roundtrip are included with the above prices. Any mileage above that will be billed at sixty cents per mile. Dependent upon distance, a minimum of three or more applications may be required for reservation.

### Salon Fee \$ Set by salon

If services are to be provided at a salon, Bride is responsible for receiving permission from salon management and any fees charged by that salon for the use of their premises. These arrangements should be made between client and salon.

### Delay Fee: Every 10 minutes \$10

- Please have your entire bridal party readily available for back to back applications.
- Client delays will be charged to the bride or that of whom made the initial reservation.
- Client delays may not allow an efficient amount of time for all planned applications to be complete.
- No charge for overage time due to makeup artist.

### Tattoo Cover-up Makeup Application \$ Size and locations dependant

Pricing depends on size and location of tattoo, must be scheduled in advance, and is subject to a \$50 deposit paid at the time of booking. Video conferencing available for price quote. Trial is optional and subject to trial pricing if being booked with a trial. Also subject to cancellation policy. If for a member of the wedding party, Bride's family, or Groom's family, subject to deposit guidelines per "Bridal Family & Party Airbrush Makeup Application" section above.



### **Methods of Payment**

#### Visa, MasterCard, American Express, Discover, PayPal and cash are accepted.

After confirming availability of your special date, you may reserve your date by placing your deposit securely through PayPal at <u>darcielmakeup.com</u> on the Services page. A business receipt will be immediately be sent to your email from PayPal on my account and within the day you will receive from me a confirmation of your deposit and reservation. A PayPal account is not required to use this method of Payment.

### **Cancellation & Refund Policy**

Non-Refundable Deposit: Sometimes life happens and you need to cancel. I completely understand that and that's not a problem. However, the non-refundable deposit is exactly that, non-refundable.

**Delays:** Delays by the bridal party that prevent me from completing the makeup applications of the entire party within the set time frame will constitute a non-refundable deposit. I work very hard to accommodate every lady, even with delays, without being late for my next scheduled client (if any).

Additional Service Fees: Any additional service fees listed under the "Additional Service Fees" section will be refunded upon cancellation.

**Cancellation and Delay due to Professional:** If for any reason I have to cancel an application due to my delay or my unforeseen circumstances, I will refund your money.

Please understand due to the nature of the wedding season that when I book an event, and by the actual day of event, I will have already turned at least one potential client away requesting the same time slot. If you later cancel your appointment turning away that client costs my company a substantial amount of money. Thank you for your understanding.
