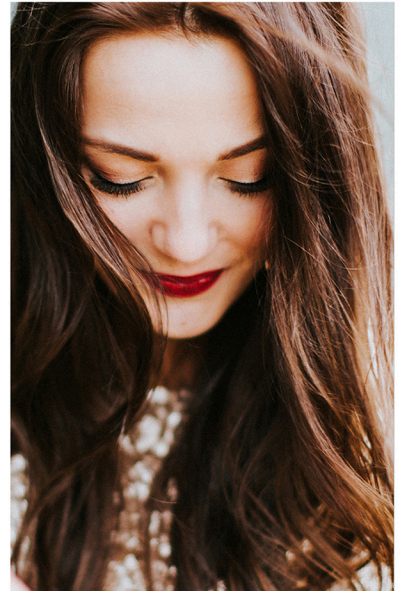

# FAQ

**Q. HOW MUCH IS THE DOWN PAYMENT, AND WHEN IS IT DUE?**

A. The non-refundable retainer fee is 50% of whichever Collection you choose, and is due at the time of signing the contract.

**Q. WHAT TYPE OF PAYMENT DO YOU ACCEPT?**

A. Cash or Check. I also accept credit cards, but there is an additional 3% processing fee.

**Q. DO YOU HOLD DATES?**

A. No, I do not hold dates. First come, first serve.

**Q. WHEN WILL I RECEIVE MY WEDDING IMAGES?**

A. Approximately 6-8 weeks after your wedding day.

**Q. DO I OWN THE COPYRIGHT ONCE YOU'VE RELEASED THE DIGITAL IMAGES TO ME?**

A. No, I own the copyright to your images. You will receive a print release, which allows you to print at any lab without our watermark or logo applied.

**Q. ARE THERE ANY TRAVEL EXPENSES?**

A. There is no travel fee within 30 miles of our office. After the 30 complimentary miles, it is 50 cents per mile. There may be a fee for lodging if your wedding is taking place 2 hours or more from my office.

## CANCELLATION POLICY:

The non-refundable retainer fee cannot be refunded. If the client cancels this Agreement 179 days or less before the event, the client must pay the full wedding collection fee. If the client cancels this Agreement 180 or more calendar days before the event date, any future payment to Danae Herrmann Photography will be cancelled.

## THE PROCESS

1

**BOOK YOUR DATE**

Pre-consult chat.  
50% of payment & signed contract is due.

2

**SCHEDULE YOUR ENGAGEMENT SESSION**

Schedule engagement session 6-9 months prior to wedding date.

3

**YOUR E-SESSION**

Lots of kissing and hugging!

4

**TOUCH BASE/ BALANCE DUE**

3 weeks prior to your wedding, your remaining balance is due. This is also when we will go over the timeline of your big day!

5

**BEST DAY EVER!**

6

**RECEIVE YOUR IMAGES**

A USB of your edited images will be sent to you 6-8 weeks after your wedding.
