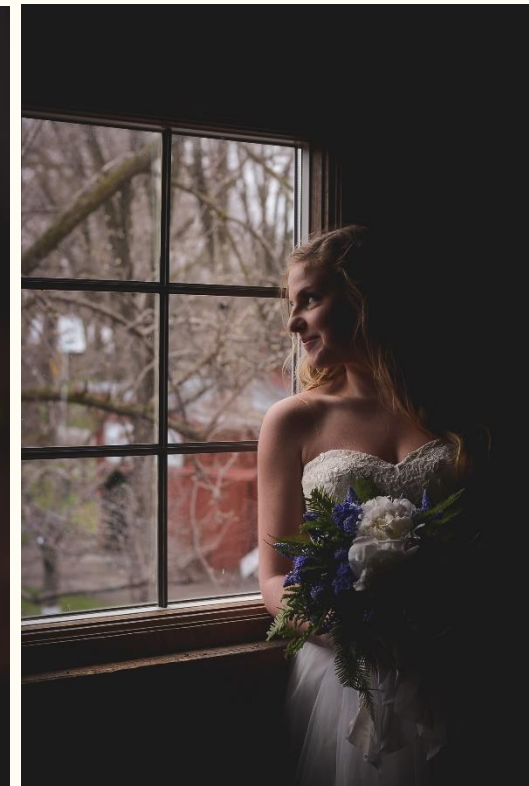

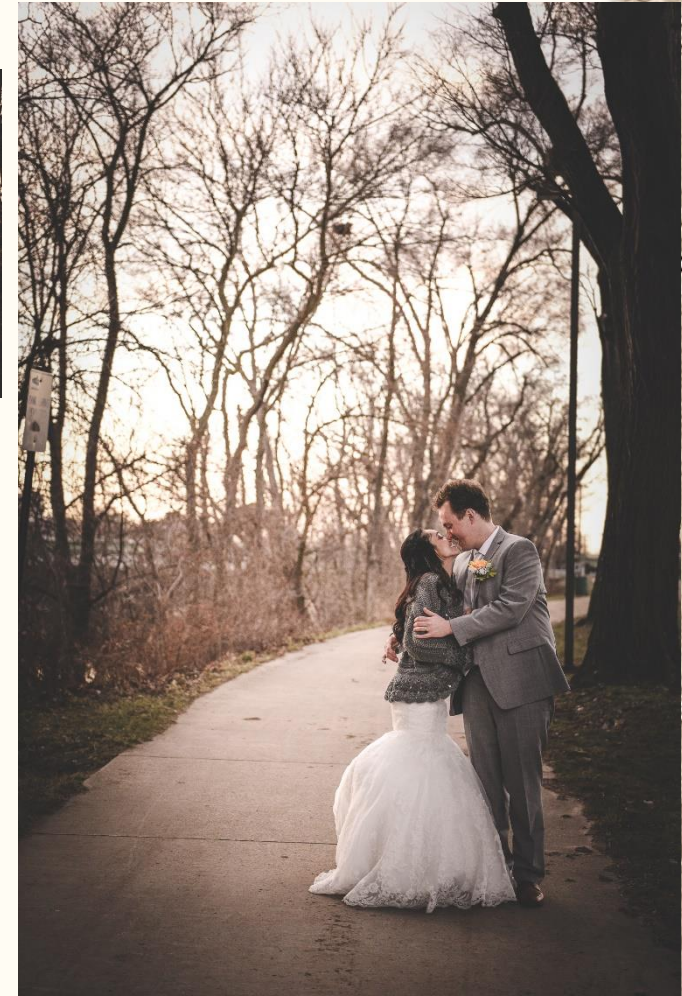

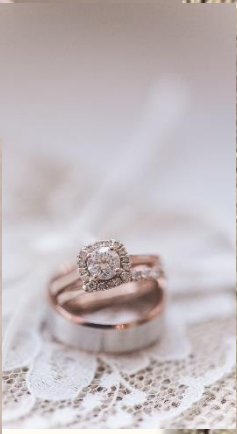

post production...

{ archiving }

The first thing I do the night of the wedding is download my cards directly onto my external hard drive. Then transfer to a second external hard drive. I then upload all images into Photoshop Lightroom in sections. Cards are never cleared until the week after wedding when I have double checked all files are backed up on my hard drives.

{ culling }

I will cull the images as soon as possible. Standardly 1-2 weeks post wedding. I will sort through and keep all images that are to my standards. I will then organize them into five folders: Pre-Ceremony, Ceremony, Formals, Mr & Mrs and reception. I will title this folder "Original" and I will title my edited files "EDITED"

{ editing }

I will provide a few sneak peaks the weekend of the wedding. I will then edit each folder one at a time. I will post a few favorites on social media sites as they are completed. {facebook and IG} All watermarks must remain visible if sharing and/or making mention of Forever Images by Melissa Ann, LLC. I will upload edited images, by groups, onto my external hard drive as they are completed, and then directly into your gallery on Zenfolio. Password protected gallery will then be sent to you via email to include link to view, download and print ordering. Allow 6-8 weeks for completion. Allow 8-12 weeks during fall season months.





The contract terms & agreement are the only legally binding documents between the Parties.

Agreement Overview

This agreement contains the entire understanding between the Photographer and the Client. It supersedes all prior and simultaneous agreements between the Parties. The only way to add or change this agreement is to do so in writing, signed by all the Parties.

Change of Date or Venue

The Photographer must be notified immediately of any changes in schedule or location, at least one week prior to the scheduled date of the session. Notification of any changes can be made by phone along with written notice sent via email for documentation. It is the photographer's responsibility to confirm all arrangements at least 7-10 days prior to the event. In the event of change of address or contact information (time, etc.) as listed, you must notify the Photographer.

Retainer

A retainer fee of \$25.00 is required for all portrait sessions, excluding weddings. A retainer fee of \$250.00 is required for all wedding packages. This is a **non-refundable retainer due within two weeks of booking along with a copy of the signed contract**. In the event of cancellation, the retainer paid is non-refundable. No date is reserved until a retainer & signed contract is received. The balance of the complete package price must be paid before or on the day of event. If final payment is not received, the Photographer will not be expected to attend. Retainer fee and signed contract is to be mailed to PO Box 315 Bremen, IN 45606. Please provide photographer notification as to when retainer and contract has been sent. Photographer will then notify client once received.
