Bridal Contract

At Studio 90, it would be our pleasure to create your perfect bridal look! We take great pride in what we do so your satisfaction is most important. We really look forward to working with you on your special day.

In order to secure your date with Studio 90, a 20% estimated nonrefundable deposit is required. This payment will be applied to the total cost the day of your wedding. To make sure your special day is flawless, it is important to come in for a trial. This allows for minimal questions the day of your wedding and we can get right to creating your style.

If there is another bride interested in the same date, you will be contacted and have 24 hours to place your deposit, or the other bride will have the opportunity to secure that date.

Our salon provides a calm, relaxing atmosphere and it is a perfect way to start your wedding day. However, if traveling is necessary there will be a non-refundable fee determined by distance from Studio 90 to your venue, and there will need to be at least four clients receiving services. **Only dry styling is available for weddings where traveling is required. There will be a \$20 fee for every client that has wet hair the day of the wedding. Overnight accommodations will be required for weddings where more than 1.5 hours traveling time and a start time before 9:00am is necessary.**

- Everyone must show up at the same time, there are no specific time slots or appointments for anyone
- Make sure to have your veil, flowers or headpiece with you for the trial and the big day
- Bring pictures of styles you like and don't like with no guarantee that this will be suitable for your hair type
- The bride's style is unique to her
- Have a blowout the day before your wedding so your hair is prepared for your designer
- Inform anyone accompanying you to the salon to wash their hair the day before the wedding
- Hair needs to be clean, dry and un-straightened the day of the wedding
- No haircuts in the month leading up to the wedding
- Please wear white to your hair and makeup trial

Delays

A late fee of \$10 will be charged for every 10 minutes of delay when a client is late for the scheduled time. (This also applies to on location services, party must meet Designer at desired location at the time scheduled.) If a wedding party is late for the scheduled service appointment time and notifies us of a new arrival time, the Designer may or may not be able to accommodate the new arrival time and the client will be charged a late fee. If the original contract cannot be fulfilled due to tardiness, services may be reduced; however clients are liable for the original amount.

Cancellation Policy

As part of our Bridal Contract, Studio 90 requires credit card information to reserve these appointments. We do ask that should there be a need to adjust or cancel any of your appointments that all changes are made 72 hours prior to the date of the appointment. If changes or cancellations are made with less than 72 hours notice, the entire cost of the adjusted or canceled services will be placed on the credit card. **Please note, we can only accept cash and/or credit cards as payment for your bridal services.**

Additional Provisions

Dispute Resolution. In the event of a dispute between the parties hereto, the parties agree that New Hampshire law shall apply, and the parties further waive the right to a jury trial and agree to submit any dispute arising hereunder, including the enforceability of this contract and any terms hereunder, to the NH Circuit Court, 10th Division, Portsmouth, NH. The parties agree that the Court shall award reasonable attorney’s fees to the substantially prevailing party.

Notices. Any notices, requests, demands and other communications pursuant to this Agreement shall be sufficient if in writing and delivered in person or sent by facsimile transmission, by registered or certified mail, postage prepaid, or by a nationally recognized overnight delivery service to either party at the above addresses.

Binding Effect. This contract shall be binding upon the members, managers, officers, employees, agents, successors, assigns and legal representatives of the parties and shall inure to the benefit of the parties hereto, and any subsidiary or affiliate of the parties.

Entire Agreement: Amendment: Waiver. This contract constitutes the entire agreement between the parties hereto with respect to the subject matter of this contract and supersedes all prior representations and agreements with respect to such subject matter. This contract may not be amended, modified or waived except by a written instrument duly executed by the party against whom enforcement of such amendment, modification or waiver is sought. The failure of any party to require the performance of any portion or provision of this contract, or the waiver by any party of any breach of this contract in any particular case will not prevent any subsequent enforcement of such portion or provision or to be deemed a waiver of any separate or subsequent breach. This contract may be signed in counterpart, and a facsimile or copy shall for all purposes be deemed an original. The parties hereto acknowledge that they have had the opportunity to consult with legal counsel, fully understand the terms herein, and agree to be bound by such terms.
