Terms & Conditions

SERVICES – Responsible for full coverage of event. This includes photographing venue, client, guests, entertainers, food and drinks and any other point of attraction or element of event.

PAYMENTS – Package price is to be paid at the start or end of the wedding day. Any additional services such as overtime or accidental damage cause by guest attending the wedding will be added to the package price. Payments can be made in cash, local bank transfer or by local cheque. If paid in USD, please note that the currency exchange rate will be 2.6.

BOOKING FEE/DEPOSIT – To secure the booking, a nonrefundable 50% deposit is required prior to wedding day. The remaining balance due will be paid at the start/end of wedding day. Payments can be made in cash, local bank transfer or by local cheque. If paid in USD, please note that the currency exchange rate will be 2.6.

POSTPONEMENT/CANCELLATION – In the event of a postponement or cancellation of the planned event, the deposit will not be refunded. However, if already paid in full, the difference will be returned.

OVERTIME – A grace period of 30 minutes is given after the completion of the contracted hours. Client or Client Representative will be approached 30 minutes before the contracted hours are over if the event seems to not meet completion on time. Once approved, overtime will be accounted for. Each additional hour will be USD \$250.

LIMITATION OF LIABILITY – In the event of the Photographer being too ill or injured, it will be the responsibility of Zoé J. Richards Photography, LightbyZoe, to find a replacement photographer of the same standard. If no replacement is made, then liability is limited to a refund of any payment received from Client or Client Representative. In addition, it is possible that human error intervenes that would result in the unfortunate event of lost, damaged or stolen files or equipment. In these situations, liability is limited to the refund of any payment received.

DELIVERY OF FINISHED PRODUCT – The turnover time for finished product is 4–6 weeks. If the client has any issues with the product, it must be communicated to Zoé J. Richards Photography, LightbyZoe, within 7 days of receipt. The issue will be addressed within 4 days of receipt. If no issues have been reported, it will be regarded as satisfactory.

CREATIVE PRODUCTION – It is understood that the minimum number of photographs of any event is based on the package agreed upon. Zoé J. Richards Photography, LightbyZoe, reserves the right of creative discretion. Note that all photographs taken on the day may not all be delivered due to the following: vulgarity, outfit mishaps, and any other unfavorably instances.

EXCLUSIVE RIGHTS – Zoé J. Richards Photography is the exclusive official photographer for requested services in this contract. Zoé J. Richards Photography reserves the rights to use excerpts (within reason) from your event for social or promotional purposes. If clients do not wish for Zoé J. Richards Photography to use excerpts, please communicate this upon receipt of product.

FORCE MAJEURE: Zoé J. Richards Photography, LightbyZoe, will not be held accountable for any pitfalls in production due to problems beyond our control. For example: bad weather, accidents, poor lighting, interference from guests, time limitations, inappropriate/offensive attire and any other unfavorable instances.

PRODUCTION AND EDITORIAL CONTROL – Similar to point 8, Zoé J. Richards Photography, LightbyZoe, is granted full production and editorial control by the customer regarding all aspects of the production and post-production for this event. All suggestions and comments from the client with regards to the style and content of the final product will be considered. However, if client desires for changes, an additional fee will be applied for time to resume post production.

CONFIDENTIALITY – Client and Client Representative are confidential about all price lists, contracts, financial documents and agreements, and any other information, that are the property of Zoé J. Richards Photography, LightbyZoe. Client and Client Representative agree to neither reveal this information to anyone (especially other photographers) or attempt to use this information against Zoé J. Richards Photography, LightbyZoe.

COPYRIGHT & REPRODUCTION RIGHTS – The Client receives images via a link with personal password. With this link and password, the Client has permission to share with whomever they like. Client is allowed to print and use photographs on their personal social media accounts with credits given to Zoé J. Richards Photography. However, the copyright remains with Zoé J. Richards Photography. Client and Client Representative agree to not use or sell any photographs taken within this contract. Sale or any commercial use of photographs by Client or Client's vendors is not allowed without prior written consent from both parties. If permission is granted, all parties must give credit to Zoé J. Richards Photography, LightbyZoe.

MODEL RELEASE – Client and Client Representatives grant Zoé J. Richards Photography, LightbyZoe, permission, free from liability and claims, to use the photographs taken of their guests for advertising purposes (within reason) without restriction.

REFRESHMENT BREAK – Zoé J. Richards Photography, LightbyZoe asks that a courtesy meal(s) be provided for the staff assigned to this event. To maintain creative focus and the best end results, we ask for a quick refreshment break of 20 minutes for events over 3 hours. In the event that meals are not granted, please notify and be mindful that Zoé J. Richards Photography, LightbyZoe, will not be held responsible for missing coverage during the break.
