PARKING FEES: if parking, valet or toll fees are incurred, the amount will be included with the final bill and due for payment on the day of the event.

TRAVEL FEE: A mileage fee of \$.75 cents per mile will be charged for locations outside of a TEN (10) mile radius of the Town of Lagrangeville , NY 12540. The amount will be determined at time of inquiry.

SATISFACTION GUARANTEED: During consultation, specifics will be discussed and agreed to client's satisfaction. Ample time will be given for each makeup session upon booking. By signing this contract, you indicate all matters and specifics have been discussed and/or noted prior to event. Acceptance of completed makeup application by client(s) is acknowledgement that makeup is done to his / her satisfaction day of event.

LIABILITY: All brushes and makeup products are kept sanitary and are sanitized between every makeup application. Makeup products used are hypoallergenic. By signing this contract, you agree that any and all skin condition have been reported by the client(s) to the makeup artist prior to application And, if need be, a sample test of makeup may be performed on the skin to test reaction. By signing this contract, Client(s) agree to release Glitzndglamour and the makeup artist (Carly A. Wolert) from liability for any skin complications due to allergic reactions.

SERVICE LOCATION AND REQUIREMENTS: Location of service for the day-of-event will be at the discretion of the client, depending on the set-up location and circumstances, there may be certain requirements that the makeup artist needs to complete the makeup applications. (if needed) A "set up" table/work area must be made available for the makeup artist at said location upon request. Other such amenities (if needed) including but not limited to sufficient lighting, additional chairs, etc must be available at makeup artists request.
