This contract is required to book any services for hair styling, makeup applications and such. A 50% deposit of service total is due at time of signing. This contract must be signed by the person making the final payment and contracting the services of hair stylist Taylor Brown and makeup artist Shaunell Davis.

•Fees •

-Bridal Hair: \$125+

-Bridal Makeup: \$125+

-Bridesmaids: \$85+

-Trial Hair: \$85

-Trail Makeup: \$85

-There is an \$100 charge for early call times which is anything BEFORE 8a.m.

-Late fees are \$25 for every 15 minutes late after scheduled start and end time BASED ON SCHEDULE PRE-MADE AND AGREED ON BY CLIENT AND WEDDING BEAUTY TEAM.

-If there are any parking or valet fees, they must be paid by the client a with the final payment. The artist(s) will pay for the fees up front but must be reimbursed afterwards. A receipt will be provided as proof of parking/valet fee total upon request.

•Cancellation•

-All deposit money will be refunded if contract is canceled within 3 days of contract signing. After 3-day grace period should the client cancel the booked event or services all monies will be forfeited.

-In the case the makeup or hair artist cancels the appointment or services 110% of the deposit will be refunded within 2 weeks by money order.

•Satisfaction Guarantee•

-Hair & Makeup will be completed to satisfaction of client within allowed time.

-A schedule will be provided to Bride of call times for bridesmaid's hair and makeup. A schedule will be made out, please have the person signing this contract fill it out and return to artist.
