# DETAILS...



## Food and Beverage Minimums

Your event requires a minimum food & beverage guaranteed dollar value that will be discussed with your Catering Sales Executive. This amount is based upon the date, time, & location of your function. If your expected attendance multiplied by the per person. Price falls below the minimum dollar value, you may increase your per person price by purchasing additional food and/or beverages, or pay the difference.

## Policies

All food & beverage must be provided by the Marriott Kansas City Overland Park Hotel, with the exception of the wedding cake & traditional items. Outside catering services must be approved by the Catering Sales Executive or the Event Planner. The sale & service of alcoholic beverages are regulated by the State of Kansas.

## Deposits & Cancellations

The first deposit due with your signed agreement is equal to 25% of the food & beverage minimum for your event. An additional 30% of the food & beverage minimum is due six months prior & 60% is due three months prior. The estimated final balance is due ten days prior to the event. All deposits are non-refundable & coincide with cancellation fees if the event is canceled.

## Guarantees

A final guarantee of attendance is required 3 days prior to your event to ensure a successful event.
