If making adjustments, final head count and payment must be made 7 days prior to the Wedding date. Weddings must be paid in full 7 days prior to wedding date. Bride is responsible for all parking, toll, and travel fees. There are no travel fees for locations up to 45 minutes away from our location. Payment Accepted via PayPal or by Credit Card via the telephone.

If the makeup artist needs to be at your location before 7am or on the road to your location before 6:00 am, an additional \$50 will incur. We cannot hold a wedding date without a signed contract and deposit. By signing this contract, I have read and understand the terms and conditions outlined above. I will abide by this contract.
