Terms and Conditions:

Please be aware that we have created this reference based on our experiences and have compiled it to make your wedding day a success for all included! We love smooth sailing so please read through and feel free to contact us with any questions you may have.

- **The minimum contract is 5 person minimum for hair AND makeup not including travel and gratuity.**
- We will not be able to hold a date for a party without a signed contract. A correspondence alone via email, text, or telephone is not a binding contract until we have the signed paper.
- Please have an accurate count for guests you expect to have services. If the number changes, we may not have an extra stylist on hand to accommodate. If the number becomes less and we book an extra stylist, we may incur fees to compensate the stylist. The person signing the contract is responsible for the number of guests/services expected. Any remaining balance will be charged to the credit card on file.
- We reserve the right to charge for the expected services (according to the contract) if you choose to cancel within 90 days of the event.
- We schedule our timing on the day of your wedding based on our experience. If you know you have a guest that may require more time, please let us know. Although we create a timeline in advance, we ask that all parties be present and ready at the beginning of the day.
- Full payment is due a week before the wedding. We will send out an invoice 30 days prior. We accept check, credit cards or Venmo. We do charge a 3.9% processing fee for credit cards
