2. Client assumes all responsibilities for obtaining any necessary permission, clearance permits, etc., which may be required for Woodnote Media to video each event, public or private. Client assumes all responsibility for obtaining and retaining permission for access to any requested camera positions and is solely responsible for the quality of the final production resulting from the use of, or inability to use, such camera positions. The client warrants that he/she has the legal rights to anything Woodnote Media will videotape, including photos, musical recordings, videotapes, or any other materials delivered to Woodnote Media for inclusion in the clients deliverables. The Client agrees to indemnify and hold Woodnote Media harmless for any loss, damage, or liability for infringement of any rights arising from the use or sale of media the client hires Woodnote Media to produce, edit, or duplicate.

3. Woodnote Media reserves the right to use videos for display, publication or other purposes. All video masters and raw footage remain the exclusive property of Woodnote Media.

4. The client reserves the right to terminate the contract for any reason at any time up to two weeks before the date of the event. Should the client terminate the contract, all money paid less the retainer will be refunded.

5. The client has critically viewed samples of Woodnote Media's work and hereby grants full editorial and production control to Woodnote Media regarding all aspects of the production and post-production services for the event. In the event a particular segment of the event is either not recorded, partially recorded, or not a part of the edited deliverables, it is at the sole discretion of Woodnote Media as the exclusive producer of the event video recording. Changes requested to the final video after delivery to client are charged at a rate of \$85 dollars an hour.

6. All personal property provided by client to Woodnote Media for utilization in the post-production of their is received by Woodnote Media at the complete and total risk of the client. Woodnote Media will make every effort to insure the safekeeping of a client's personal property while in its possession and return same to client upon delivery of goods.

7. If Woodnote Media fails to comply with the terms of this agreement due to any event or at beyond the control of Woodnote Media, including but not limited to illness, accident, labor disputes, acts of God and other catastrophes, or uncontrollable and unforeseeable equipment failure, Woodnote Media's liability is limited only to a refund of all monies received.

Q. How long does it take to finish our video?

A. We spend between 60-70 hours editing your video and work on weddings as efficiently and quickly as possible. We can't give an exact date as to not sacrifice the quality of the product. However, we try to deliver every products within 90 days of the wedding. **We will notify you when the finished video is completed.**

Q. How much is your retainer? When do I pay you the remaining balance?

A. The retainer is non-refundable deposit of 30% of the total price of the booking. The remaining balance is to be paid two weeks prior to the wedding date.

Q. How do we get our wedding video and/or photos when it is finished?

A. When we email you to inform you that your video and/or photos are finished, you will receive a download link to all items.
