EVENT SPACE RENTALS

The rental fee varies depending on the day, time, and space reserved. A minimum food and beverage purchase as well as a minimum food purchase per head is required. The food and beverage minimum may be negotiable depending on the size of your group. There is a \$100 set up fee for the bar with 2 hours bartending included. The bartender is \$25/hour per bartender thereafter. A 20% service fee will be applied to the total bill.

MENU SELECTIONS AND GUARANTEES

Menu selections and final head count must be confirmed two weeks prior to event date. You will be billed for the confirmed number of guests or the actual number served, whichever is greater. If a guarantee is not received, you will be billed based on the initial estimate given. Any increase in numbers or requests for menu changes 10 days before the event are subject to a 20% premium above the published price, if it is possible to provide the requested change.

CONTRACT & PAYMENT POLICY

Each event requires an advance deposit(s) and a signed contract, with the balance of all charges due at the conclusion of your event. 50% of the quoted price is due 2 weeks prior to your event date. We accept cash, credit card, and check; however, a credit card must be placed on file. Invoicing is available, if requested at least one week in advance. All invoices must be paid within one week from event date.

This signed contract and site fee deposit as indicated are required to reserve a date. The deposit goes towards the balance of your final bill. If paying with cash or check, a credit card must be placed on file. All cancellations must be received in writing. If cancellation occurs 60 days in advance of the scheduled event, 1/2 of the initial deposit will be returned. Cancellations received less than 60 days before the scheduled event, forfeit the entire deposit. 50% of the estimated total charges will be due two weeks prior to the event date. Any cancellations occurring after one week of the event date, the 50% charge will be refunded. Any cancellations occurring after the one week mark will forfeit the 50% charge. Should cancellation occur after 10am the day prior to your event date, 100% of the quoted price will be charged to the card on file. The balance of all charges is due at the close of the event.
