## FIRST LOOKS

I know - seeing each other before the ceremony could be “bad luck” or ruin the special moment of seeing each other as the doors open and the bride walks down the aisle. But I promise, none of this is true! There are many benefits to a first look:

- More time to hang out with your guests. Instead of taking photos immediately after the ceremony, you can go straight to your cocktail hour - and enjoy it!
- Your makeup will be fresh (the crying and nervous sweat hasn't happened yet) - and extra built in time will even allow for touch ups before the ceremony.
- You get time alone!! Holy crap this is so important. Being able to take a second and just completely focus on each other during this whirlwind day. This day is about you two, so why spend more time apart?
- You aren't rushed. Instead of rushing through photos after the ceremony and worrying that your guests are getting impatient at the cocktail hour, you get to take time with one another and soak in the day. Breathe, laugh, cry and take your time.

It takes time to create beautiful and candid images, it's not something to be rushed. In order to create my level of work, I require at least 45 minutes for couples portraits. Don't worry! I will help you create a timeline for your big day. We will make sure there's enough time for portraits and celebrating with friends & family!

I WANT TO KNOW MORE

**Q: Is the reservation fee/deposit refundable?**

**A:** The reservation/deposit fee is non-refundable.

**Q: How do you accept payment?**

**A:** I accept payment by check, Venmo, and Paypal. All online servicing fees must be paid by the client.

**Q: What do we do if it's raining on our wedding day or engagement session?**

**A:** We make it work on your wedding day, if needed we can shoot bridal images another day - if outdoor portraits are necessary. I am willing to reschedule engagement sessions due to poor weather conditions.

**Q: How many images can we expect from our engagement or wedding?**

**A:** You will receive roughly 150+ images from the engagement shoot. Final wedding images are around 600+ depending on the package / time limit.

**Q: Do you post everything you shoot online?**

**A:** I do my very best to post every session online. I love to post them on Instagram using stories and individual posts. They will also be featured on my

website and Facebook page. If you DON'T want to be featured just let me know!

**Q: Do we need a second shooter?**

**A:** I feel that second shooters are a must at weddings with 250+ guests. That is the only way I can comfortably get images featuring your guests. I love having a second shooter to provide extra detail shots, and another set of creative eyes to make art.

**Q: Does it cost to have you travel to our wedding? How much?**

**A:** I am based out of the Omaha - Sioux Falls area. So anywhere around the hub of Nebraska, Iowa, and South Dakota traveling will be free. I have outlined the cost of travel in my pricing section, if I must travel further.

**Q: What do you shoot with and are you insured?**

**A:** I shoot Canon equipment and I am insured.

**Q: How do we pick photo locations?**

**A:** Photo locations are best chosen as places that mean something to you! Or if you're looking for a certain vibe or mood, we choose locations based on your goals. We can choose these locations together when we have our Skype / FaceTime date or meet in person!



***Q: Can we order prints of your images or does that cost extra?***

**A:** I send an online photo gallery full of beautiful images and you are allowed to print them anyway you please. I love seeing framed photos that I've taken, or photo books. I don't have an ordering site hooked up for prints yet, which is why I allow my clients to print as they please.

***Q: Can I have unedited versions of the photos or the RAWs?***

**A:** I will never give clients the unedited versions of photos or the raw files. That is my creative property, and it's written in my contract.

***Q: Can we bring our dog? Can we bring props?***

**A:** UHHH YES PLEASE!! I love doggos and cats and all kinds of animals. Even cows!! Anything we can use to capture your full essence and personality is OK by me. If you guys grew up riding around in his pick up truck, let's take some cute photos in the truck bed with blankets and your pupper! I love it.

***Q: How long until we get to see our photos?***

**A:** I do my absolute best to work as quickly as possible while keeping the integrity of the images

and giving you my best work. With that, plan to allot at least 7 weeks to receive your image gallery. Of course, I usually get things done sooner.

***Q: Does the photographer retain the copyright to the images? Does that mean we can't share them?***

**A:** I do retain the copyright to the images. Which means that yes you can share them, I will just need to be fully credited online and in each post you create. You should credit each photo with MECS Photography in the caption. You are more than welcome to tag my Instagram or Facebook page as you see fit, but my business name must be featured in your post.

***Q: Can you shoot just our engagement session if you're not available for our wedding?***

**A:** I would love to!! Engagement sessions are so much fun. I am more than willing to shoot your engagement even if I'm unavailable for your wedding.

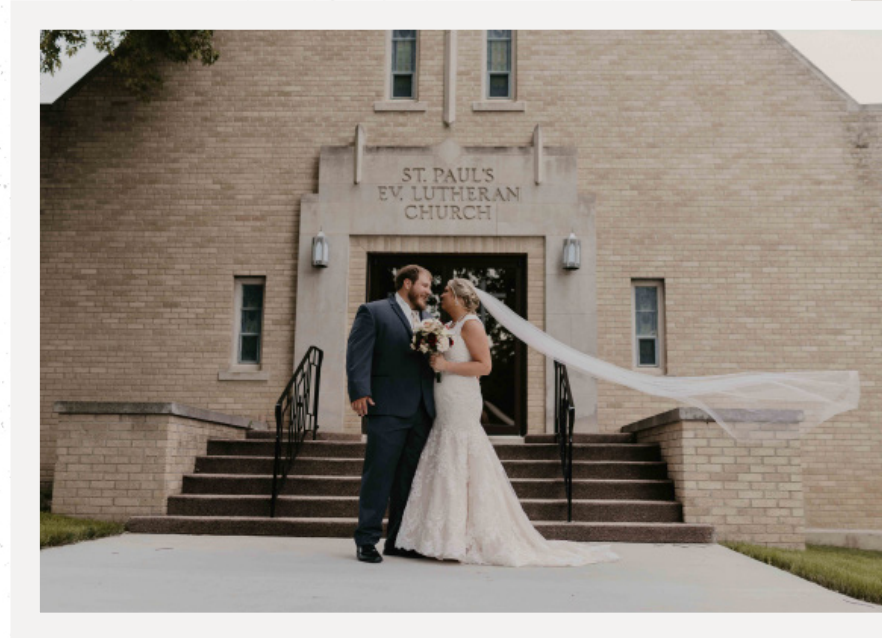

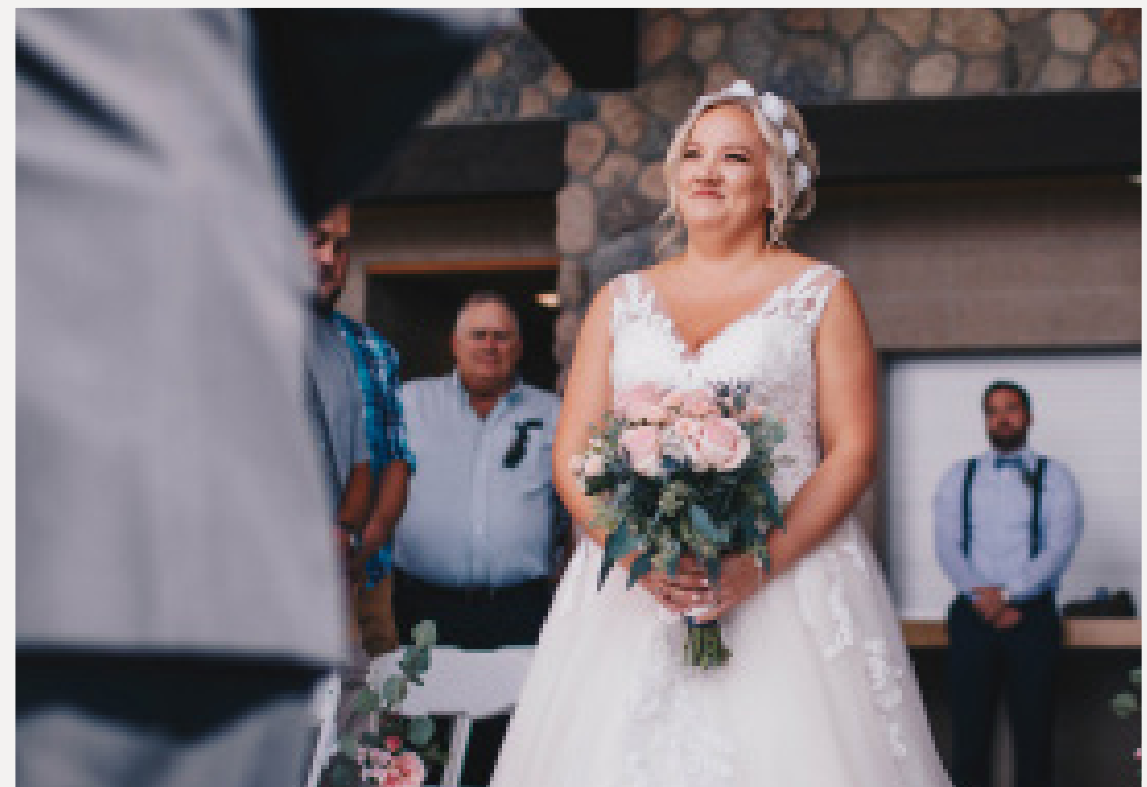
