This bridal service contract is to ensure we have all information needed for your wedding day & to protect C + C Bridal if you choose to cancel after the non refundable deposit is paid.

**\*Travel Fee (\$1 per min) will be added to brides service costs.**

**\*Nonrefundable \$100 booking fee is due when the contract is sent back.**

**BALANCE PAYMENT DUE:**

The balance will be due the day of your wedding. We take a few minutes at the end to collect payment. The travel fee (\$1 per min) will also be added to the brides service cost and an automatic 20% gratuity will be added to each individual service performed that day.

**BOOKING:**

Your appointment date and service will be secured when the signed contract and booking fee are received. The booking fee is non-refundable and non-transferable. **The booking fee DOES NOT come off the grand total.**

The balance will be due the day of your services.

**HAIR & MAKEUP TRIAL:**

You may request a trial run as early as 3-4 months before the wedding, they are not required. Trials are not included but can be purchased for at an additional charge. We will offer a discounted price for trials as shown below.

## **HEADCOUNT:**

We require a set headcount of the number of services and what services you will need 3 months before your scheduled event date. Any changes in the amount of services must be made **AT LEAST 30 DAYS BEFORE THE EVENT DATE**. In the event that the headcount of services changes less than 30 days from the scheduled date, the bride will be responsible for paying for the canceled services that were originally supposed to be performed.

## **PAYMENT:**

The named Client in this contract is responsible for the entire balance of payment.

All payment can be made with **Venmo, Apple Pay, Cash or Check**

## **TRAVEL:**

A mileage fee of **\$1 per minute** will be charged for any travel of more than 15 miles to the service location (We are based in Dupon, IL). Hotel accommodation the night before the scheduled appointments will be required for any travel of more than 100 miles.

## **MISCELLANEOUS FEES:**

All costs incurred for travel and delivery of this service, including but not limited to: airfare, hotel, parking, valet, tolls, etc must be paid by Client.

Where such costs are incurred, the amount will be invoiced separately and due 30 days from the wedding date.

## **DELAYS:**

Everyone having their hair done should do the following and be prepared to start when the Artist arrives:

- Have hair clean and dry
- Have face clean and makeup free (if having makeup)
- Wear a zip up or button down top, something that can be removed easily once hairstyle is complete

It is your responsibility to communicate this information with your bridal party. In the event scheduled services exceed the allotted time due to bride or wedding party delays, I will make every effort to accommodate everyone. However this is solely at my discretion and based on my availability.

I can/will work with your wedding planner and/or photographer in coordinating the schedule where required.

Please note that in all likelihood I will not be able to accommodate any last minute additions of appointments.

## **PHOTOGRAPHY:**

The location of services for the day-of-event will be at the discretion of the Client, but there are certain requirements the Artist will need to complete the services. A set-up table/work area/chair/trashcan/outlet if using airbrush will need to be made available. Ample lighting, whether by means of natural light or by lamps, is necessary for services to be performed properly.

Photos or videos may be taken for promotional use and advertising purposes on my website, portfolio, social media, brochure, etc. You agree to me taking and using such images as described and release me of any and all claims regarding use.

Where photos/videos are taken by a professional photographer/videographer they will be contacted to release the photographs/recordings. Full credit will be given to them for their work. This signed agreement serves as a release authorization for such materials.

### **CONFIDENTIALITY:**

All information provided by the Client shall be treated with confidentiality and will only be available to the Artist and any other relevant party you agree to e.g. photographer or wedding planner. Your personal details will not be made available to any other party without your express agreement.

### **LIABILITY:**

All brushes, tools, and makeup products are kept sanitary and are sanitized between every makeup application. Makeup products used are hypoallergenic. Any allergies and/or skin conditions should be reported prior to application and, if necessary, a sample test of makeup may be performed on the skin to test reaction. The Client agrees to release the Artist from liability for any skin complications due to allergic reactions.

### **CANCELLATION / RESCHEDULING:**

Any cancellations or changes to services, number of people in the party, etc must be made 2 months before the wedding day. In the event that you cancel your appointment less than 2 months before the reserved wedding date, you will be required to forfeit your deposit.

**CLIENT RESPONSIBILITIES:**

It is the Client's responsibility to provide a safe working environment for the Artists. This includes but not limited to: securing any insurance required, providing an adequate service location, maintaining clear communication and providing a safe space free of harassment, harm or discomfort of any kind.

The Artist reserves the right to terminate this contract immediately for any breach of terms, and the contract will become void and all monies given are non-refundable. This booking arrangement cannot be changed after the Artist arrives for the appointment.

By signing this document, you agree to have your appointment scheduled under the Terms and Conditions of this contract.
