## POLICIES

**BOOKINGS:** To secure a date, a signed bridal contract and **\$50.00** deposit are required. This deposit is non-refundable and non-transferable, also this deposit will be taken off ‘*Bridal Day Of Hair*’ price (discussed during consultation) The remaining balance will be due on or before the day of the event. Accepted forms of payment include: cash, check, and all major credit cards. Gratuity is never expected but always appreciated. (NOTE: bridal consultations and deposit fees are two separate costs.)

**CONSULTATION:** Consultations/trial runs are *required* for all brides and available for their bridal party members. (*Gentri & Company Salon - 106 Rockspring Road, High Point, North Carolina, 27262*) Here at the salon, we will sit down and discuss your hair goals. We will go over a time frame of the full day. *Bring between 2-3 inspiration pictures.* This contract and all cancellation policies will be reviewed and a credit card/check deposit (\$50.00) will be collected during this time. NOTE: Additional consultations must be scheduled on the same day as the bride’s consultation.

**SATISFACTION GUARANTEED:** Hairstyles will be completed to the client’s satisfaction, and acceptance of the completed hair style is acknowledgement by the client that the style is done to the client’s satisfaction.

**PARKING FEES:** Where parking, valet or toll fees may be incurred. This amount will be included in the final bill and will be due on the day of the event. (Parking fees/tolls must be paid by bride if applicable)

### TRAVEL FEES:

Travel fee for first 20 miles ..... No charge  
Each additional mile after 20 miles ..... \$0.50/mile both ways  
*\*parking fees/tolls must be paid by bride if applicable\**

-Travel within 20 miles of High Point, North Carolina is completely free of charge. A mileage fee (\$0.50/mile both ways) will be charged for locations outside of the 20-mile radius of High Point, North Carolina 27262.

**PAYMENT:** The final balance is due on wedding day *or* during consultation. The person(s) responsible for the *full* balance of payment is the person(s) whose name(s) appear on this contract. (If persons are paying separate, payment will be taken after each style for zero confusion)

**CANCELLATION POLICY:** Cancellations must be made at least thirty (30) days prior to the client’s reserved date or the client will be responsible for paying the full amount of services agreed upon in this contract.

## **Important Information for your Bridal Service**

### **KEEP THIS PAGE!**

To help me serve you better and ensure your wedding day runs as smoothly as possible, I ask that you and your wedding party follow these easy guidelines...

- Any person(s) getting blowout, arrive with clean, product free hair, for best smoothing results.
- Please arrive with clean, dry hair in its natural state to help hold your hairstyle
- For best results for updo's, hair should be washed the day before and kept free of styling products
- *Bridal Party* - Remember to wear a button down shirt to keep your hair from being touched after it's been perfected for the big day
- **BRIDE:** Consider wearing white to your hair trial run. This way you'll be able to see your true hair color as it's being styled (or a shirt with a similar neckline as your wedding dress)
- During your trial run, please bring everything you think you are going to wear on your big day so you can get a good feel of the completed look, (veil, jewelry, hair pieces or accessories, etc.)
- Please DO NOT hesitate to bring inspiration pictures we can look at together to determine what hairstyle works best for you and accentuates you in the best way. Keep it at a minimum of 2-3 pictures. Also, bring a picture of your wedding dress. (keep in mind, the more complicated style will take longer time to complete)

**\*\*Most importantly, be honest with me about what you like/dislike! I want you to be happy and feel beautiful on your wedding day!**
