Package 3 – \$3,500. The premium package; you receive deluxe services for an all-inclusive price.

Add-on Premarital Counseling and Wedding Officiant Services:

Payment Policy:

A nonrefundable deposit of 50% of the total package price is due at signing and reserves Dr. Emily Cook as your wedding officiant for your wedding date. Remaining package balance is due no later than 30 calendar days prior to the wedding date. Payments are accepted only by check, made payable to Emily Cook Therapy LLC.

Cancellation Policy:

Cancellations are handled on a case-by-case basis, and may or may not be refundable (excluding the nonrefundable deposit). In the very unlikely event that Emily must cancel due to an emergency, she will provide a suitable replacement officiant.
