Standard Package is Six hours of Photography coverage: \$850

This includes:

One hour of Ceremony Preparation: Bride in her gown, Rings, Accessories, Flowers and Decor (as well as any personal requests of posing or shots)

Ceremony coverage: Procession, Vows and exchanges, Guest speakers, Musicians and Recessional

Group photos of the Wedding Party: The small group photos can take place before or following your Ceremony.

Bride & Groom's Family Photos: The Family group photos can take place before or after your Ceremony, at the same time as the Bridal Party Photos or a different time and/or location.

Examples: Bridal Party photos are scheduled before the Wedding, and Family will be following the ceremony and before the Reception.

These can be taken at the site of the ceremony or elsewhere, i.e. Nearby beach or park, inside a church, inside the Reception hall, or outside of the ceremony location.

Reception: Decor, food, cake, speeches, dances, cutting of the cake, and of your guests (as well as any personal requests).

Cost also includes: travel within 20 miles of Escanaba MI.

- There is a \$.50 per mile travel fee for locations farther than 30 miles.
- There is no additional cost for my set-up, tear down or lighting prep. This will not be a part of your six hours.
- I am available for additional hours Pre-ceremony or Post-Ceremony. Cost is \$75 per hour. I am also available to meet you at your rehearsal.

You can have any photo printed from this gallery by professional printing labs. There are multiple print options from regular print sizes to photo gifts, cards and memorabilia. You may use this for purchasing your prints in conjunction with your proof book or independent of. This gallery will be completed within 30 days of your wedding.

You will also receive 15 to 25 copyrighted high resolution digital photos within 15 days of your wedding. These will be added to an additional gallery on the photographer's website www.frozenbyjill.com. You are able to download these photos to your computer, iPad or even your smart phone to use online (Facebook, Twitter, Email).

If you choose to have your photos printed elsewhere, you will need to pay for the copyright to all photos. The cost is an additional \$150 due with total balance. You will received all edited photos on a USB card with a copyright release form within 30 days of your wedding.

The photographer retains all rights to use all images for portfolio, samples, self-promotions or for profession competition or online review but will not use images for any other purpose without obtaining written permission from client(s).
