- A non-refundable deposit in the amount of \$50, made payable to Stephen McNeill, is required to guarantee the booking of this event. The remaining balance of _____ shall be paid on the day of the wedding before the prelude music begins. Cash, checks, and electronic payment through the Cash app (send payment to stephenkmcneill@gmail.com) are accepted.
- If the CLIENT(S) cancels the performance, they must directly contact the ARTIST at least 30 days prior to the event. If the performance is cancelled within 30 days of the event, there is a \$100 cancellation fee, due within 14 days of cancellation.
- CLIENT(S) will ensure that the required equipment is provided at the ceremony/reception venue for the performance. Required equipment includes one chair with no arms and a nearby power outlet; for outdoor engagements, a shaded area (i.e. canopy, gazebo, or large umbrella) must be provided in order to avoid exposing instruments/equipment to direct sunlight or rain.
- In the event of inclement weather (including tornado warnings, winter storms, or flood conditions) which render the ARTIST's attendance unsafe or impossible, the CLIENT(S) will be refunded all fees paid, minus the non-refundable deposit.
- If the ARTIST cancels the performance for personal reasons (illness, emergency, etc.), any deposits or fees paid will be refunded in full.
- Any parking fees will be paid by the CLIENT(S).
- Specific song requests must be made at least 30 days before the event.
- The ARTIST expects the event to begin and end on time. If the event begins more than 15 minutes later than agreed upon, a fee of \$25 will be assessed.
