### NOW WHAT? WEDDING PHOTOGRAPHY PLANNING TIMELINE

- **1. Wedding Photography Services Agreement & Deposit –** This agreement, along with the non-refundable \$500 deposit needs to be mailed back to me to confirm my services for your event. You can also scan the signed contract and email me the PDF. I will then sign it myself, and email you a scanned version of our contract.
- **2. Optional Engagement Session –** This is a great opportunity to get comfortable in front of the camera before your wedding and for us to get to know one another better. These images can make for great additions to wedding day décor, save the dates, or more awesome shots of you together. Take advantage of this \$350 value!
- **3. Open Communication & Questionnaire –** Most likely this is your first time planning a wedding. Let me help you in the process! As you are in planning mode, I will email you a questionnaire and general wedding day timelines to help guide you.
- 4. **Remaining Balance Due, Timeline & Group Photo List** Your remaining balance is due *one week* prior to your wedding day. I will also need your confirmed wedding day timeline and your family photo list.

**5. Wedding Day –** Everything will be all set to go. Relax and enjoy your day!
