BOOKINGS: To secure a date, a signed contract is required with a 20% deposit due at the time of signing. The deposit is non-refundable and non-transferable. Please be advised, dates and scheduled makeup times will only be reserved when a signed contract and deposit are received.

DELAYS: A late fee of \$25.00 will be charged for every 30 minutes of delay when a client is late for the scheduled time, or if scheduled makeup exceeds allotted time because of client delays. Contract will state the times late fees will begin and the amount charged and will be initialed and approved by client.

SATISFACTION GUARANTEED: Makeup will be completed to client's satisfaction, but is not to exceed allotted makeup time. Ample time is given for each makeup upon booking.

SERVICE LOCATION AND REQUIRMENTS: Location of service for the day of the event will be at the discretion of the client, but there are certain requirements the makeup artist needs to complete the makeup applications. A "set up" table /work area needs to be made available for the makeup artist at the location.
