DVD Cases

These cases are each custom designed from the images from your special day. Sessions such as Engagement, Bridal, Just Married, Anniversary, etc will have a case designed with one DVD inside and all Wedding cases will have the two disc format.

FAQ

Q: So, who are these people?

A: David and I are husband and wife and even more important we are mom and dad to our wonderful children Chad and Allie. We love capturing moments that happen in life through our lenses. You will be able to look back at the images we take and be able to actually feel the emotion of your special day. Nothing makes us more happy than to see the smiles on our clients faces when they see their images and know that we played a small part in making their day memorable for a lifetime.

After a wedding, even with screaming achy muscles and sore feet, we can't stop talking about the day.. sharing our excitement over images we captured, how great the experience was, and how honored we are to be invited to participate in the celebrations of so many people. We get excited about our work, and we truly hope that that excitement shines through in the images that we capture for our clients. We want to be more than "just another vendor" that you have booked for your wedding. We want to be a friend that you can trust will give individual attention to your day and will listen to your needs and desires before, during, and after your wedding. We can't wait to get started!

Q: What professional organizations are you affiliated with?

A: We are members of Wedding & Portrait Photographers International (WPPI).

Q: What does my money buy?

A: A significant number of hours are put into each individual wedding before, during, and after the wedding day. Here is a breakdown of our time commitments from an average wedding:

- Pre-wedding meetings and on-site planning meetings (2-3 hours)**
- Photographing the wedding (6 – 14 hours)**
- Photographing bridal, engagement, or trash the dress (2-6 hours)**
- Proof-editing all images and set up of online galleries (10-20 hours)**
- Album designs, revisions, and ordering process (15-30 hours)**
- Print credit and order fulfillments (5-15 hours)**

This does not take into account retail value of actual product delivered (albums, prints, proof magazines, etc)

Q: Do I own my images?

A: Yes! We definitely understand the current trend of owning your proofs for your own printing purposes. Therefore, with every package you will receive full-resolution versions of your proof-edited digital image files with a copyright release that will allow you to print your own photos. You will also receive web-optimized versions of all of your images for easy e-mail and web sharing!

Q: How do we book you as our wedding photographers, and how much is the retainer to hold my date?

A: Contact us to obtain a copy of our standard wedding contract. Both the signed contract and a flat retainer fee of \$600 (subtracted from package price) are required to secure your wedding date. The remainder of your balance will be due 14 days before your coverage begins.

Q: How many weddings do you shoot per day?

A: We only book one wedding per day, so you will have 100% of our focus during your coverage.

Q: I'm not getting married on Saturday. Is there a discount for this?

A: Yes! For weekday weddings (including Friday) we apply a 20% discount to your package, and for Sunday weddings we apply a 15% discount to your package.

Q: What methods of payment are accepted?

A: We accept cash, personal check, or credit/debit card (Visa, Mastercard, Discover, American Express, or Paypal)

Q: What is the benefit of having two photographers at my wedding?

A: With both of us shooting, you will not only have more complete photojournalistic coverage of your wedding, but more variety in your portrait sessions as well. While Amy handles the direct interaction with the people she is photographing, David stands offangle using long lenses to take a different approach to the same subjects that Amy is photographing at the same time. This allows us to provide you with a very unique collection of portraits. Before the ceremony, David & Amy can separate so that you can have photojournalistic coverage of both the ladies and the men preparing for the day.

Q: What kind of equipment do you use?

A: We shoot with the professional line of Canon digital SLR cameras. At full resolution, our digital images files can produce stunning prints up to 40x60 and beyond (we recommend canvas for larger prints). We use Canon's exclusive line of "L" lenses, and we work with a variety of lens types (zoom, wide-aperture primes, macro, extreme wide angle, etc)

Q: Do you photograph using a standard shot list?

A: No way! We shoot every wedding uniquely, playing off of the differences and special features of each one. Although we may repeat some of our ideas, we are always stretching our creative muscles to strive to capture each wedding in unique and beautiful ways.

Q: Can I order prints online?

A: Absolutely, and so can your friends and family! Every client receives an online password-protected gallery of every image from your wedding. The gallery is also a nifty shopping cart, making ordering prints fast and easy!

Q: How long after the wedding will I have to wait to see my images?

A: During wedding season (Spring, Summer, and early Fall), you can expect to have your online gallery available 3-6 weeks after your wedding day. Any included printed proofing or high-res DVD sets will be available within 2 weeks of the gallery launch date.

Q: How many photos will we see?

A: Engagement, Bridal, Couples, or Just Married sessions will yield 100-300 proofs, while weddings can range between 500 – 1,500 proofs, depending on how much coverage you purchase.

Q: Are there any hidden fees we should know about?

A: If you are unable to pick up your photos or albums from our studio, we will charge shipping to send these items to you. We do not charge shipping for high-resolution DVDs.

We do charge small travel fees for venues outside of a radius of 50 miles from our studio. Please contact us with specifics about your venue and we will be happy to quote a fee for you.

Q: How does the album process work?

A: Our studio will draft an initial custom design draft for you to see online. You will be able to request any needed revisions to this design, giving you final creative control over the look of your album. Album design time runs 8-12 weeks, while album production time is 4-6 weeks.
