A non-refundable 50 % deposit of _____ is due upon booking and will be deducted from the total cost of the selected services. Please note, the remaining balance is due two-weeks prior to the event date.

ENTIRE AGREEMENT: This document is the official agreement between One Shot Media (“STUDIO”) and the Client. Agreements made prior to or outside of this contract are null and void. Any change to the document must be made in writing and signed by both the STUDIO and CLIENT.

RESERVATION AND LIABILITY: Upon the signing of this document and the receipt of the non-refundable 50% deposit, the STUDIO will reserve the date of your wedding and will not schedule any event conflicting with the shooting of your wedding. The deposit will be applied toward the total price of the package agreed upon above, the remaining balance due no later than two weeks prior to scheduled event. The deposit is non-refundable if the wedding is cancelled for any reason. The deposit is refundable only if circumstances beyond our control prevent us from taping your wedding, including but not limited to STUDIO's equipment failure, STUDIO's equipment malfunction and STUDIO's defective tape stock. Under all circumstances, the STUDIO's liability is limited to a full refund of monies paid.

HOUSE RULES: The STUDIO is limited to the guidelines of ceremony official or reception site management. The responsibility of securing the permission to shoot the ceremony at the wedding and reception location is that of the CLIENT. The deposit is not refundable if videotaping is prohibited. All parking and similar charges will also be billed to the client before the video is delivered.

EXHIBITION / MODEL RELEASE: In signing this contract, the CLIENT is acting as agent for all members of the party including family, friends, guests, and staff and grants the STUDIO all rights for display, airing, exhibition, promotion, contests and advertising of all images and video produced under this contract.

DELIVERY OF VIDEO: Normal delivery of the finished video will be within 12 weeks of the event. If extra materials such as photographs are to be added to the video, they must be delivered to STUDIO within two weeks after the wedding. An extended delivery schedule needed to properly complete the video will not void the contract.

DRONE POLICY

It is agreed that drone footage will be provided under the assumption of appropriate weather conditions and under all Federal Aviation Administration (FAA) guidelines in accordance to 14 Code of Federal Regulations Part 107 and any temporary flight restrictions (TFR's) on the given date and time of the event.

Outside of weather restrictions, FAA guidelines and TFR's, drone operation will fall under "HOUSE RULES" (see contract) portion of contract and STUDIO will assist in this determination.

If weather restrictions or TFR's prevent drone footage, CLIENT will still be liable for the cost of booking a second shooter and will gain the benefits of this service for the duration of the event.

The STUDIO will make every effort possible to provide drone service.
