*I will provide the following services for my fees under the terms of this agreement:*

- \$250 service w/Rehearsal; \$150 simple services –Prices subject to change according to ceremony
- Phone/email consultation with the couple to discuss ceremony details
- I reserve the right to refuse any service that I am not comfortable performing
- I will arrive 30 mins prior to the scheduled ceremony time.
- Mileage is \$1.50 per mile if out of my radius

The couple may use my likeness in any photographs, videos, or other recording media in any manner for any purpose they wish. Likewise, that couple gives permission for Midwest Ordained Minister/Wedding Officiant to use their likeness in at least on photograph for marketing purposes. To hold your date a 25% deposit is required you have up to 30 days to cancel for refund back any later will forfeit the deposit.

**Marriage License**

For a legal marriage to take place, the couple must obtain a valid marriage license in the state where the ceremony will take place. The marriage license needs to be presented to the officiant BEFORE the ceremony. Failure to have a valid license means that the officiant cannot perform a legal marriage ceremony. Two adult witnesses are also required to be present.

**IN WITNESS WHEREOF**; the parties hereto agree to the terms and conditions as described above and have caused this Contract to be signed on the date indicated below. This contract, once signed, is considered by all parties within to be legal and binding in accordance with the conditions set forth herein, and shall abide by the agreed upon terms.

*This agreement is valid for the wedding service for the place and date stated above. If the couple changes the time or date of the scheduled ceremony without the Officiant’s consent, the Officiant reserves the right to cancel the performance of the ceremony, and shall in no way be held responsible or liable in any manner for such non-performance. The couple accepts responsibility for purchasing items needed to perform the ceremony (unity candles, sand, roses, etc.) unless previously stated. This agreement and any attachments constitute the entire agreement between the parties and may not be modified except in writing signed by both parties. No other representation or promises have been made except those that are set out in this agreement stated above.*
