- KG Photography may substitute another photographer to take the photographs in the event of official Photographer's illness, medical emergency or scheduling conflicts. In the event of such substitution, KG Photography warrants that the substitute photographer taking the photographs shall be a competent professional.
- No part of any order, including previews, will be delivered until the balance is paid in FULL. \$ 3,500.00 is the agreed amount to be paid by the client to the photographer. This amount will include the following: "COLLECTION 2" - Up to 8 hours coverage time, 1.5 hour engagement session, 1.5 hour bridal session, 20x30 gallery wrapped canvas, two photographers, 10x10 - 20 page linen storybook album and all high res images and print release. The 25% retainer (\$ 875.00) is due to hold your wedding date. The remaining balance (\$ 2,625.00) is due two weeks before the wedding date (XXXXXX XX , 2016).
- KG Photography retains copyright of all images and reserves the right to use negatives and/or reproductions for advertising, display, publication, or other purposes. Digital negatives remain the exclusive property of KG Photography.
- Upon signature, KG Photography shall reserve the time and date agreed upon, and will not make other reservations for that time and date. For this reason, all retainers/reservation fees and previous payments are NON-REFUNDABLE, even if the date of the wedding is changed or cancelled for any reason. *INITIAL HERE:* _____
- If KG Photography cannot perform this contract due to fire or other casualty, strike, act of God, or other cause beyond the control of the parties, or due to Photographer's illness or emergency, then the Photographer shall return the retainer to the Client but shall have no further liability with respect to the contract. This limitation on liability shall also apply in the event that photographic materials are damaged in processing, lost through camera malfunction, lost in the mail, or otherwise lost or damaged without fault on the part of the Photographer. In the event KG Photography fails to perform for any other reason, KG Photography shall not be liable for any amount in excess of the retail value of the client's order.
- The charges in this contract are based on the KG Photography's Standard Price List. This price list is adjusted periodically and future orders shall be charged at the prices in effect at the time when the order is placed.
- This Contract incorporates the entire understanding of the parties. Any modifications of this Contract must be in writing and signed by both parties.
