Your wedding will most definitely be the most important day of your life. Trust Griffith Photography with your precious memories; we will work with you to ensure we capture every detail of your special day for you to remember for the rest of your lives and generations to come.

We offer the following package options:

Platinum ~ \$3400\* +tax

- ~ Two pre-wedding sessions (engagement, bridal)
- ~ Up to 8 of hours wedding day event coverage (two ceremony photographers and one reception photographer)
- ~ On-line and downloadable web proofing gallery with print release
- ~ A la Carte prints with \$900.00 worth of print credit for print sizes up to 8x10

Gold ~ \$2900\* +tax

- ~ Two pre-wedding sessions (engagement, bridal)
- ~ Up to 6 of hours coverage of wedding day events (one photographer)
- ~ On-line and downloadable web proofing gallery with print release
- ~ A la Carte prints with \$700.00 worth of print credit for print sizes up to 8x10

Silver ~ \$1900\* +tax (Local San Antonio Area only, not for out of the greater San Antonio area weddings)

- ~ One pre-wedding session (engagement or bridal)
- ~ Up to 4 of hours coverage of wedding day events (one photographer)
- ~ On-line and downloadable web proofing gallery with print release
- ~ A la Carte prints with \$400.00 worth of print credit for print sizes up to 8x10

\*Take 10% off of any session if you pay in full on the day you book! Package prices do not include sales tax, 8.25% tax will be added to all prices.

Travel outside of the greater San Antonio Area: .50 per mile and lodging expenses applies for Platinum and Gold Packages. Silver Package is only for weddings in the greater San Antonio area.

Booking your wedding ~ A retainer equal to half of the package price is due at the time of booking to hold your wedding date. This retainer is applied to the balance due and is non-refundable. Half of the remaining balance is due 30 days before the date of the wedding. The remaining balance is due 7 days before the wedding date.

Hours of coverage ~ Coverage begins when the photographer is scheduled to arrive and continues until scheduled to leave. For example, the photography coverage is normally booked to capture the bridal party getting ready, (about an hour or more before the ceremony). Be sure to schedule enough coverage for your ceremony and plan out the reception to ensure all the major events are covered. Additional coverage can be purchased for \$375.00 per hour and additional photographers are also available for an additional fee. During the ceremony and for the pre-wedding coverage, an extra photographer is a great idea if not already included in your package. Prices are subject to change; all prices quoted at time of paid booking will be honored.

An on-line proofing gallery will be available for viewing within 12-14 days of the ceremony. Proofing Galleries are fully downloadable and include a full print release; however proofing gallery images are not retouched. All prints and products purchased on [www.griffithphotographyllc.com](http://www.griffithphotographyllc.com) will be fully retouched prior to printing at a professional lab.

### 1. A SUMMARY OF THE CONTRACT

Griffith Photography is responsible for providing for the client a photographic service and products as detailed in section 2 ('coverage'). The client undertakes to engage the photographer for this coverage for the price as detailed in section 3.

A sneak peek of images will be available on the Griffith Photography Facebook page unless clients request otherwise.

### **3. PAYMENT ARRANGEMENTS**

The client will pay the photographer a total fee of \_\_\_\_\_ +tax (8.25%) subject to the following terms:

A retainer equal to half of the package price +tax is required to secure the date and payable on execution of this agreement. This deposit is non-refundable or transferable in the event of cancellation, it being the agreed loss suffered by the photographer due to cancellation.

Half of the remaining balance is due 30 days before the wedding and the final payment is due 7 days before the wedding.

Cancellation less than 12 weeks before the date of the wedding will require payment in full. All cancellations must be in writing. The cancellation conditions above will apply for postponed weddings if the photographer is not able to re-schedule for the new date and time. The fee for postponed weddings is subject to change.

Any additional payments for albums and other services are to be made when that order is placed. Prices for orders placed over one month after the date of the wedding may be subject to change. This includes orders that are part of the initial wedding package, if applicable.

#### **4. COPYRIGHT**

Griffith Photography retains the entire copyright in the photographs at all times throughout the world. Prints and images online will not be scanned, copied, downloaded, cropped, altered or otherwise used without the express written consent of Griffith Photography. These include pictures on Facebook and other social media. The photographs are for personal use only and not for commercial use.

Griffith Photography retains the right in all cases to use the photographs in any manner at any time and in any part of the world for the purposes of advertising or otherwise promoting their work.

#### **5. IMAGE SIZE, COLOR, STYLE AND COMPOSITION**

All image sizes are approximate. The photographer will provide a pleasing color balance but cannot guarantee exact color matching. It is sometimes not possible to record in print the exact color as seen by the human eye. There is no right to reject on the basis of style or composition.

#### **6. ATTENDANCE**

In the unlikely event of the photographer is unable to complete the coverage due to unforeseen circumstances, the photographer reserves the right to appoint another photographer to attend on his behalf to undertake the photography.

Due to the commitment to weddings and family portrait sessions on the weekends, engagement/pre-wedding portrait shoots are arranged Sunday to Thursday. The

location of the engagement/pre-wedding portrait shoot is within 20 miles of Cibolo, TX. Otherwise, a charge may apply.

## 7. LIMITATION OF LIABILITY

In the unlikely event of a total photographic failure or cancellation of this contract by either party or in any other circumstances, the liability of one party to the other shall be limited to the total value of the contract. Neither party shall be liable for indirect or consequential loss.
