WHAT TO EXPECT

Taylor Shots Weddings (ts.wed) operates in phases to make sure you, your photographer, and Taylor Shots are all on the same page for your big day. The outline below goes through the 5 phases and goes in depth about what the different phases look like for you. Additionally there are resources about Taylor Shots and how to contact us.

CONSULTATION PHASE

about 2 weeks

Once you've booked you'll need to schedule a consultation. The consultation will be conducted by one of our employees to find out more about what you're looking for in your photographer and any additional services that you request so that we can build you a quote. This process is completely free and no payment is required to schedule a consultation and you will receive a final quote following your consultation. Once you approve of the final quote and sign the contract you will be responsible for the deposit which is approximately 40% of the value of your shoot. You can cancel up to 7 days before your event date for a refund excluding a cancellation fee that will vary dependent on the cancellation date.

WELCOME PHASE

1+ months

After signing your contracts and paying your deposit you will be paired with your photographer for the wedding day and matched with any other photographers for additional services such as engagement sessions. From this point on your main contact will be your matched photographer who will have all the notes from your consultation as well as your contact, venue, and vendor information. The welcome process is the entire period 7 days prior to your event so things like engagement sessions and makeup trials will all come in this part of the shoot. If you run into any issues during this period you can contact your photographer. If you have any issues with your vendors, portal, payments, or contract questions you can email support@taylorshots.com.

EVENT PHASE

8 days

We're a week out from your event, that's super exciting! This phase is the final stretch until the big day so it involves things like sending a confirmation of what's happened and what to expect for the coming days and the rest of the process. The confirmation email will include things like photographer names, services applicable to the wedding day, vendor names, and vendor travel itinerary (if applicable).

EDITING PHASE

6-8 weeks

After your event you'll receive an email recapping your event and outlining a timeline of when to expect your photos. The editing process takes the longest amount of time and requires a lot of processing to get the photos into a deliverable state to you. The process for photos takes about 6 weeks to complete and the photos will be delivered in your portal under the "Galleries" section upon completion. Files will not be available to you for download until you have paid in full for your shoot. You will also receive an email once your photos have been uploaded. Video can take up to 8 weeks to complete following your event and videos will also be delivered to you in your portal under the "Files+Documents" section.

CLOSEOUT PHASE

1 week

Once you have paid in full for your shoot you will then receive all of your files (photo & video) in your portal. You will have access to these files for 30 days to download them and store them on your own computer via your portal. In this phase you can request additional edits up to 7 days after receiving your files. All files after 30 days will expire and become unavailable but you can request copies of your files up to 1 year after the event date. After 1 year, photos are subject to deletion and cannot be recovered once deleted.
