Booking & Deposit ~

All written discussion via The Knot, Wedding Wire, email, and text message are legal-binding documentation. A review of the contract and all details will be discussed and agreed upon prior to booking. A deposit must be made for booking to be official. Deposits are non-refundable. Your deposit amount is your travel fee.

Trials ~

TRIALS ARE REQUIRED FOR GOOD REASON! If you believe you are not in need of a trial, exceptions can be made by speaking with Leah. Trials include an unlimited amount of services and people; hence it being marked at an hourly rate. If your event is not booked prior to the trial and you do not plan on booking at the end of the trial, your trial rate is \$100 per hour. If you decide to book later, the extra \$40 per hour paid at the trial will be applied towards your booked event costs. Trial service fees are due on the day of.

Services & Packages ~

Service prices are listed above and non-negotiable. We strive to keep our costs low as a small business to help cater to brides of all budgets because we believe everyone deserves to feel beautiful. Leah will sometimes adjust pricing for extremely short/long hair. Anyone who has extremely curly hair and requires pressing needs to have that done prior to receiving a formal style from any artist at Payneless Beauty. **WET OR DIRTY HAIR WILL NOT BE SERVICED!** If a guest is assumed to have an infectious or contagious skin or hair disorder, we have the right to decline them for servicing. We must abide by all state sanitation laws. All makeup applications include strip or cluster lashes. If you choose to not have lashes applied, your makeup application is \$75. Our "Detroit Diva" package includes a hairstyle and makeup application with lashes, if desired. Our "Miss.Michigan" package includes a trial, any facial hair removal necessary, a mini facial for relaxation and to prep the skin for a flawless makeup application, a take-home hair mask for camera ready shine and your hair and makeup on the Big Day! **DON'T FORGET ALL OUR BRIDES LEAVE WITH A GIFT!** We also service all party attendees 12 and younger for FREE within reason and availability!

Payments ~

All service fees are due on or before the day of the event - NO EXCEPTIONS! Deposits and payments can be made via Venmo, Cash App, Zelle, Paypal to @paynelessbeauty or by debit/credit card. All electronic payments have a \$5 processing fee. For any payment over \$100, there is a \$5 fee for every \$100 paid electronically. Cashier checks or money orders are accepted and must be made out to Leah Payne and mailed to 850 Ridgewood Drive, Townhouse 4, Fort Wayne, IN, 46805. Cash or check payment can also be exchanged in person. PERSONAL CHECKS ARE NOT ACCEPTED!

Delay ~

A \$30 late fee will be charged for every 30 minutes of delay when a client is late for the scheduled time, or if the scheduled service exceeds the allotted time due to client delays.

Traveling & Parking ~

Based on location and start time, a \$100 hotel fee will be assessed in addition to mileage fees for every event. This is established before booking. Any parking, valet or toll fees will be added to the total balance.

Changes, Cancellation & Postponement ~

Any changes such as date, time, venue, service amount or any variance from the agreement prior to booking needs to be discussed with Leah immediately to ensure accommodations can be made. Any changes made with less than 24-hour notice or cancellations less than thirty (30) days prior to the event may subject the client to being responsible for paying the full amount of services agreed upon prior to booking. With the recent pandemic, we have been exponentially accommodating to our guests. Your deposit is transferable if we are available on your new date, but always non-refundable. Any changes to your event other than the date may be subject to proper price adjustments.

Additional Services ~

Please notify Leah prior to booking if you need any additional services such as hair removal, manicures, toe polish touch-ups, etc.

Liability & Satisfaction ~

All stylists are trained and licensed professionals! We always deliver the best quality product, tools, and skill! All tools and products are sanitized and/or disposed of between every event and guest. Any allergies and/or skin conditions should be reported by the client to the stylist prior to application and, if need be, a patch test may be performed to test reaction. Client(s) agree to release any artist working under Payneless Beauty from liability for any reason.
